## **ORDINANCE NO. 1199-062022**

### **AN ORDINANCE APPROVING A TEXT AMENDMENT TO SECTION 14-3-1 OF THE OGLESBY LAND DEVELOPMENT CODE SO AS TO AUTHORIZE SPORT AND RECREATION, PARTICIPANT AS A PERMITTED USE IN A B1 DOWNTOWN COMMERCIAL DISTRICT IN THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS**

**WHEREAS**, the City Council of the City of Oglesby requested its Plan Commission consider a Text Amendment to Section 14-3-1 of the Oglesby Land Development Code so as to authorize “Sports and recreation, participant” as a permitted use in a B1 Downtown Commercial District; and

**WHEREAS**, the Oglesby Plan Commission conducted a public hearing on June 6, 2022, to consider such request, after due notice as provided in the Illinois Municipal Code and the Land Development Code of Oglesby, Illinois; and

**WHEREAS**, at the conclusion of said hearing the Oglesby Plan Commission recommended to the Oglesby City Council that Section 14-3-1 of the Oglesby Land Development Code be amended so as to authorize “Sports and recreation, participant” as a permitted use in a B1 Downtown Commercial District; and

**WHEREAS**, at its regularly scheduled meeting on June 6, 2022, the City Council of the City of Oglesby, LaSalle County, Illinois, considered said recommendation and approved the amendment of Section 14-3-1 of the Oglesby Land Development Code so as to authorize “Sports and recreation, participant” as a permitted use in a B1 Downtown Commercial District; and

**WHEREAS**, the Oglesby City Council deems it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to adopt this Ordinance to

formalize the amendment of Section 14-3-1 of the Oglesby Land Development Code so as to authorize “Sports and recreation, participant” as a permitted use in a B1 Downtown Commercial District, as previously approved by the Oglesby City Council on June 6, 2022,

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:**

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.

2. Section 14-3-1 of the Oglesby Land Development Code is hereby amended so as to authorize “Sports and recreation, participant” as a permitted use in a B1 Downtown Commercial District.

3. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
