The Mayor opened the floor to comments from the public on agenda items only. There were none.

A MOTION WAS MADE BY PORTER, SECONDED BY ZBOROWSKI to approve ordinance 1058-040119, Authorizing Execution and Agreement for Professional Service Between the City of Oglesby and the North Central Illinois Council of Governments. AYES: PORTER, RIVARA, ZBOROWSKI, ARGUBRIGHT, FINLEY.

Dave Lourie from T.E.S.T Inc gave a year-end review of the water and wastewater department. Some highlights that he went over: the sludge press in now working and being used, they found issues with piping in the plants and they have corrected them, the water quality has never been better. They are working on a 5 and 10 year plan along with a hydrant replacement program. Four of the damaged

hydrants are getting repaired in April or May. They are also going to have a valve assessment company come in mid-April and they will locate and test all the shut offs in the City and provide a report.

The Mayor asked for comments from the public. Sarah Cudlip asked about painting lines at the spur. Commissioner Zborowski said that they will have a crew go out this summer and take care of it. Drew Merriman asked if there was a written rule on who gets what department after an election. Mayor responded no. Drew also asked if a city employee who is on disability is allowed to work. Attorney Andreoni responded that it depends on the situation.

Commissioners and Mayor's Report:

Rivara- Commissioner Rivara announced that Vistra is retiring 32% of the coal fired generate fleets. He tried to reach out to the company to see what plants were effected and was unsuccessful. He said the result is that the price of electricity will go up this summer.

Argubright- Commissioner Argubright said that they went out for bids for the new substation transformer but found that 4 weeks wasn't long enough so they are extending it another 4 weeks.

Zborowski- Commissioner Zbrowoski said that the street department will be cleaning inlets of debris. He said there is a lot of leaf debris.

Porter- None

Mayor Finley- Mayor said that the micro pantry food drive was a big success. He reminded everyone that food is always accepted at city hall for the pantry.
