A REGULAR MEETING OF THE OGLESBY CITY COUNCIL WAS HELD ON

MONDAY, JUNE 1, 2020 AT CITY HALL. THE MEETING WAS CALLED TO ORDER AT 7:00 P.M. (The meeting was not open to the public, it was live-streamed on Facebook).

A MOTION WAS MADE BY ARGUBRIGHT, SECONDED BY LIJEWSKI to Declare a State of Emergency. AYES: ARGUBRIGHT, CULLINAN, CURRAN, LIJEWSKI, RIVARA. Attorney Andreoni explains that by doing so it can stay in effect for 60 days; it also allows for the use of outdoor dining using the City's sidewalks.

A MOTION WAS MADE BY ARGUBRIGHT, SECONDED BY CURRAN to table Ordinance 1116-061520 amending Chapter 12.20, sidewalks, of Title 12, streets, sidewalks, and public ways of the Oglesby city code. Attorney Andreoni states that by passing the proposed ordinance it would prohibit having alcohol. Attorney Andreoni goes on to explain that the amendment can be amended; if that's the case Andreoni recommends tabling the ordinance. Mayor Rivara asks if it would be better to table the ordinance and get the business owners input. Commissioner Lijewski asks if business owners attended the informal meeting on May 29, 2020? Commissioner Argubright replies that several did attend. Attorney Andreoni states there is no rush to pass the ordinance, that it can be tabled and modified. Mayor Rivara said to work with the business owners is the key to making it work. Commissioner Curran questions the effects of tabling the ordinance. Attorney Andreoni advises to wait and see how things are going and at some point, put the modified Ordinance on the agenda prior to the 60 days. AYES: ARGUBRIGHT, CULLINAN, CURRAN, LIJEWSKI, RIVARA. Commissioner Curran would like to have the bump outs addressed in the proposed ordinance.

A MOTION WAS MADE BY ARGUBRIGHT, SECONDED BY CURRAN to place on file 061520R a Resolution Committing Local Funds. AYES: ARGUBRIGHT, CULLINAN, CURRAN, LIJEWSKI, RIVARA. Commissioner Curran reiterates that it is a lot of money and that if the city does not get the grant the money will not be spent.

Commissioner Lijewski addresses item #10 on the agenda and asks that a correction be made on the verbiage. Attorney Andreoni suggests placing on the next agenda with the proper verbiage. No action is taken.

Lijewski: Ambulance had 71 calls and 22 transfers Fire department had 13 calls and 1 rescue at Matthiessen Park The Police department had 24 reports, 6 accidents, traffic stops 17, citations 3 and ordinances 3. Commissioner Lijewski states that there is extra patrol on duty this evening and there was not one vehicle at the department. There were a few complaints that came over the weekend with residents drinking outside and they will be addressing them.

Curran: 85 LED lights will be coming at a cost of \$12,750.00 to which 80% will be paid by the IMEA. The police department helped to identify which areas in town needed lights GTI has increased their electric load this week. Commissioner Curran went on to thank residents that have contacted him with their concerns. Commissioner Curran thanks the Street Department for their work.

Mayor's report: Mayor Rivara thanked Bob Ghighi, Rich Watts, Kathy Knoblauch and the clerical staff for coming up with the idea for the graduate banners. When the final graduation is done the fallen veterans banners will be put up. The drive thru is now open from 8:00-4:30 p.m until June 15, 2020 until the next phase is reviewed. Mayor Rivara states that contact has been made with a company to address the audio during the live feed of the council meetings.
