A MOTION WAS MADE BY ARGUBRIGHT, SECONDED BY RIVARA to Approve Ordinance 1025-061818, Authorizing the Execution of the First Amendment to a Land Lease Agreement between the City of Oglesby and Sellco Partnership d/b/a Verizon Wireless. AYES: PORTER, RIVARA, ZBOROWSKI, ARGUBRIGHT, FINLEY.

A MOTION WAS MADE BY RIVARA, SECONDED BY PORTER to Approve Ordinance 1026-061818, Prevailing Wages for the Laborers, Workmen, and Mechanics employed on Public Works of said City. AYES: PORTER, RIVARA, ZBOROWSKI, ARGUBRIGHT, FINLEY. The Mayor asked for comments from the public. Dave Lourie, from T.E.S.T, talked about the lift stations and the electrical issues they had due to lightening striking the transformer. He said that the City will need to do annual maintenance on the pumps with the sludge station and he will present a price proposal next month. He was happy to report that they have moved sludge to the drying beds and they are ready to test the press. He also asked residents not to flush anything that they shouldn't be, they have found numerous rags in the sewer system. These rags can cause major problems to the system.

Rivara- Commissioner Rivara said that the committee and employees did a great job with Summer Fun Fest. He thanked Commissioner Argubright and Engineer Jim Clinard on the help with the solar project paperwork.
