The Mayor asked for comments from the public. A resident asked what the scope of the 2nd and 3rd St. project is. Commissioner Zborowski said that it is black topping, curb work, and sidewalks. On 2nd St it runs from the dead end to Dale Street. On 3rd St it runs from Columbia to Kenosha.

Argubright- Commissioner Argubright said that The City has hired Mark Marincic as the new electric superintendent to replace John Zulkowsky when he retires at the end of June.

Zborowski- Commissioner Zborowski congratulated Mark Ambrose on his retirement from the City on Friday May 4 after 31 years of service. Eric said that residents wanting a sewer credit for filling their pools must contact the City Clerk's office.

Porter- Commissioner Porter said that he has noticed residents discharging grass clippings on the street. He asked that residents don't do this because it causes problems for the sewer system.
