Commissioner Curran explains that the public needs to be aware because of the recent water main breaks it is needed and could possibly qualify for grant purposes (CBD). Commissioner Argubright questions how many breaks there have been?

Mayor Rivara reads the audit report finding as presented from Hopkins and Associates.

<u>Old Business</u>: Commissioner Lijewski states that the sirens that are activated on the first Tuesday of every month cannot be changed.

<u>Argubright</u>: states the City is in a good position financially but needs to continue to be cautious and watch money going forward.

<u>Lijewski</u>: Officer Pellino is in PTI training and Assistant Chief Margis is taking leadership classes at Northwestern University. Officer Gonzalez is also signed up for a training class and a class on use of excessive force that is coming up also. Commissioner Lijewski praises the departments for doing a good job of keeping safe and healthy.

<u>Curran:</u> leaf vac will continue through the rest of the week. Two of the seven streets have the no parking signs in place. The water tower painting is now complete. The lights will need to be adjusted. The filling will be soon. Hydrant flushing will begin the week of November 30th. The electric rate study is now under way since the city audit is finished. A presentation will follow. A meeting was held the company that runs the iFiber through the city. At some point a survey may go out to the residents in regards to the city becoming fiberoptic.
