ORDINANCE NO. 1200-062022

***AN ORDINANCE ESTABLISHING
RANKS WITHIN THE POLICE DEPARTMENT
FOR THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS***

WHEREAS, the corporate authorities of the City of Oglesby, LaSalle County, Illinois have previously enacted an Ordinance establishing the Police Department of the City of Oglesby; and

WHEREAS, the Rules and Regulations of the Board of Fire and Police Commissioners of the City of Oglesby, Chapter V, Section 1, provides that, "The order of rank in the Police Department shall be as provided by Ordinance and municipal budget."; and

WHEREAS, the corporate authorities of the City of Oglesby find it necessary and deem it to be in the public interest to adopt an Ordinance establishing ranks within the Police Department for the City of Oglesby,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois as follows:

SECTION 1. The recitals contained in the preamble to this Ordinance are restated as if set out in full herein.

SECTION 2. That the following sections 2.33.090 through 2.33.120 for the Oglesby Municipal Code are hereby created and enacted:

2.33.090: DEPUTY CHIEF OF POLICE; ASSISTANT CHIEF OF POLICE:

(A) There is hereby created the office of Assistant Chief of Police.

The Assistant Chief of Police shall be appointed by the Board of Fire and

Police Commissioners as provided by statute, and the powers of the Assistant Chief of Police shall consist of the same powers and duties held by the Chief of Police during any period when the Chief of Police is sick, disabled, unavailable, or in any way incapable of performing his or her normal duties and functions. At all other times the Assistant Chief of Police shall be subordinate to the Chief of Police and shall render the same services as those performed by other members of the Department. The rank of Assistant Chief of Police shall only exist so long as the current Assistant Chief of Police (Michael Margis) is serving in this capacity. When Michael Margis is no longer serving in the position of Assistant Chief of Police, the Assistant Chief of Police rank shall be replaced with the Deputy Chief of Police position/rank as hereinafter created.

(B) The position of Deputy Chief of Police is hereby created. He or she shall be appointed by the Chief of Police. The Deputy Chief of Police shall serve at the pleasure of the Chief of Police. Anyone with five (5) years of police service or more shall be eligible to be considered for the position of the Deputy Chief of Police.

2.33.100: POLICE SERGEANT(S) AND INVESTIGATOR:

There are hereby created the position(s) of police Sergeant(s) in the City of Oglesby. The police Sergeant(s) shall be appointed by the Board of Fire and Police Commissioners based upon competitive examination from the next lowest rank, subject to the approval of the Mayor and City Council for the funding of these supervisory positions. Sergeant(s) shall be responsible for handling clerical and administrative duties along with all

other duties as assigned to them by the Chief of Police. Sergeant(s) shall render the same services as those performed by other members of the Police Department.

The Chief of Police shall be granted authority to designate one rank and file police officer as an Investigator. The designation of a police officer as an Investigator shall not be deemed a promotion nor shall it be deemed to give the Investigator supervisory authority over other rank and file members of the department. The Investigator shall be responsible for handling investigations assigned to him by the Chief of Police along with all other duties assigned to the Investigator by the Chief of Police. At all other times, the Investigator shall render the same services as those performed by other members of the Department.

2.33.110: PART TIME POLICE OFFICER:

(A) A "Part Time Police Officer" when used herein shall be defined to mean a member of the Oglesby Police Department who is employed by the City of Oglesby for less than One Thousand, Five Hundred sixty (1,560) hours in any twelve (12) month period beginning on January 1st of any calendar year and subject to the training requirements for Part Time Police Officers as may be promulgated by the Illinois Law Enforcement Training and Standards Board.

(B) The Chief of Police of the City of Oglesby shall be authorized to hire part time police officers in order to provide adequate police coverage for the residents of the City of Oglesby.

(C) The Chief of Police of the City of Oglesby is hereby given

discretionary authority to hire Part Time Police Officers as the Chief of Police deems necessary, subject to the approval of the Mayor of the City of Oglesby and further subject to the authority of the Oglesby City Council to control and limit the number of Part Time Police Officers, the salary established for Part Time Police Officers and the total hours worked by all Part Time Police Officers.

(D) All Part Time Police Officers shall deem to be at will employees of the City of Oglesby and their employment may be terminated or their hours diminished at the sole discretion of the Chief of Police of the City of Oglesby.

(E) All Part Time Police Officers hired under the provisions of this section shall complete the training required of Part Time Police Officers established by the Illinois Law Enforcement Training and Standards Board.

(F) Any person employed as a Part Time Police Officer must meet the following hiring standards:

1. Be of good moral character, of temperate habits, of sound health, and physically and mentally able to perform the assigned duties;
2. Be at least twenty-one (21) years of age;
3. Pass a medical examination;
4. Possess a high school diploma or GED certificate;
5. Possess a valid state of Illinois driver's license;
6. Have no prior felony conviction; and
7. Anyone who served in the U.S. military must have been honorably discharged.

8. If an Officer is full-time certified, numbers 1-7 are not necessary.

(G) All Part Time Police Officers employed pursuant to the provisions of this section shall not be subject to any of the provisions contained in section 10-2.1-1 et seq., of the Illinois Municipal Code and the provisions contained therein for the hiring of full-time police officers, discipline of full-time police officers and termination of full-time police officers shall not apply to Part Time Police Officers hired under the provisions of this section.

2.33.120: TOTAL NUMBER OF OFFICERS.

Additionally, the total number of officers within the Police Department, including all respective positions within the Department of Patrolmen, Sergeant, Deputy Chief, Assistant Chief and Chief of Police shall be determined by the City Council.

SECTION 4. This Ordinance shall be in full force and affect after its passage, approval, and publication in pamphlet form as provided by law.
