ORDINANCE NO. 1190-071822

**AN ORDINANCE AMENDING
SECTION 9.16.010 AND SECTION 5.92.020
OF THE MUNICIPAL CODE OF THE CITY OF OGLESBY**

WHEREAS, the City of Oglesby currently has a previously adopted a regulatory scheme that regulates indecent conduct and defines an “Adult entertainment cabaret” within the corporate limits of the City of Oglesby; and

WHEREAS, Section 9.16.010 of the Municipal Code of the City of Oglesby describes certain conduct deemed indecent or immoral; and

WHEREAS, Section 5.92.020 defines adult entertainments cabarets and enumerates activities therein in order for the Corporate Authorities to regulate adult uses; and

WHEREAS, Section 11-1-1 of the Illinois Municipal Code (65 ILCS 11-1-1) allows a municipality to enact all necessary ordinances to maintain public order and protect the health, safety, and welfare of the City of Oglesby; and

WHEREAS, Section 11-5-3 of the Illinois Municipal Code (65 ILCS 11-5-3) allows the corporate authorities of a municipality to prohibit disorderly conduct; and.

WHEREAS, the corporate authorities of the City of Oglesby have determined that it is advisable, necessary and in the best interest of the City of Oglesby to amend the language of Section 9.16.010 and Section 5.92.020 of the Municipal Code of the City of Oglesby.

NOW THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Oglesby, LaSalle County, Illinois, as follows:

SECTION 1: That Section 9.16.010 of the Municipal Code of the City of Oglesby is hereby amended and shall hereafter state as follows

It is unlawful for any person to do any indecent or immoral act, or to appear in any public place indecently or immorally dressed, or to make any indecent exposure of his or her person.

SECTION 2: That Section 5.92.020 of the Municipal Code of the City of Oglesby is hereby amended and shall hereafter state as follows:

"Adult entertainment cabaret" means a public or private establishment which: (i) features topless dancers, strippers, "go-go" dancers, lingerie or bathing suit fashion shows; (ii) not infrequently features entertainers who display "specified anatomical areas"; or (iii) features entertainers who by reason of their appearance or conduct perform in a manner which is designed primarily to appeal to the prurient interest of the patron or features entertainers who engage in, or are engaged in explicit simulation of, "specified sexual activities.

SECTION 3: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication, as provided by law.
