ORDINANCE NO. 1070-071519

AN ORDINANCE AMENDING ORDINANCE NUMBER 1024-061818 ENTITLED AN ORDINANCE ESTABLISHING WAGES FOR OGLESBY AMBULANCE SERVICE EMPLOYEES

WHEREAS, the Oglesby City Council adopted Ordinance No. 1024-061818 Entitled An Ordinance Establishing Wages for Oglesby Ambulance Service Employees; and

WHEREAS, Ordinance No. 1024-061818 provided for wages for Oglesby Ambulance Service employees through April 30, 2021, except for the salary of the Oglesby Ambulance Service Executive Director; and

WHEREAS, the City of Oglesby desires to amend Ordinance No. 1024-061818 and to provide for a salary for the Oglesby Ambulance Service Executive Director for the period from May 1, 2019 through April 30, 2020 and for the period from May 1, 2020 through April 30, 2019; and

WHEREAS, Section 11-5-7 of the Illinois Municipal Code (65 ILCS 5/11-5-7) authorizing municipalities to operate an ambulance service and to employ individuals to work for the municipality in said service; and

WHEREAS, the corporate authorities of the City of Oglesby deem it to be in the public interest of the public health, safety and welfare of the residents of the City of Oglesby to adopt this ordinance establishing a salary for the Oglesby Ambulance Service Director.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are restated and reincorporated by reference as if set out in full herein.

2. The Director of the Oglesby Ambulance Service shall be paid a salary of \$54,382.89 per year commencing retroactive to May 1, 2019 and continuing until April 30, 2020. The Director of the Oglesby Ambulance Service shall be paid a salary of \$55,470.55 commencing May 1, 2020 and continuing to April 30, 2021.

In addition to the salary set forth in this paragraph, the Oglesby Ambulance Service Director shall be eligible to earn additional compensation for staffing an ambulance handling transfers as set forth in Ordinance No. 1029-071618 entitled An Ordinance Establishing Wages for Oglesby Ambulance Service Employees Involved In Patient Transfers whenever said patient transfer does not conflict with the Ambulance Service Director's schedule.

In addition to the salary set forth in this paragraph, the Oglesby Ambulance Service Director shall be paid additional compensation for all water rescue calls for the Oglesby Ambulance Director's response to the water rescue call in accordance with the fee schedule established by the City of Oglesby and the Oglesby Fire Department for employees responding to water rescue calls.

In addition to the salary set forth in this paragraph, the Oglesby Ambulance Service Director shall be paid additional compensation at the same rate as corresponding Oglesby Ambulance Service employees when responding to a call for service which occurs outside of the ambulance director's forty-hour work week. The Director of the Oglesby Ambulance Service shall receive benefits, including but not limited to, health insurance, longevity pay, vacation days, sick days, holidays, leave of absence benefits, clothing allowance and retirement benefits on the same terms as said benefits are established in the Collective Bargaining Agreement between the City of Oglesby and its unionized, non police department employees. The Director of the Oglesby Ambulance Service shall work a minimum of 2080 hours per year, exclusive of vacation and sick days, on a schedule to be determined by the Ambulance Service Director. The Oglesby Ambulance Service Director shall not receive overtime pay for any hours worked by the Director in excess of 2080 hours per year as any additional hours worked by the Director are deemed to be part of the Director's supervisory duties and included in the Director's salary as set forth in this ordinance.

3. The salary increase provided herein for the Oglesby Ambulance Service Director shall be paid to the Oglesby Ambulance Service Director retroactive to May 1, 2019.

4. All of the provisions of Ordinance No. 1024-061818 not otherwise modified by this ordinance shall remain in full force and effect.

5. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
