ORDINANCE NO. 1084-091619

AN ORDINANCE ESTABLISHING FEES FOR PROVISIONS FOR DISPOSAL OF TREE BRANCHES AND LAWN CARE REFUSE

WHEREAS, the City of Oglesby desires to establish procedures and charges for the disposal of tree branches and yard trimmings; and

WHEREAS, the City of Oglesby currently provides for semi-annual disposal of tree branches and yard trimmings in the spring and fall of each year at no cost to the residents of the City of Oglesby; and

WHEREAS, when severe weather causes damage to trees and other vegetation in the City of Oglesby, the City of Oglesby, pursuant to direction from the Commissioner of Streets and Public Improvements, also collects and disposes of tree branches and yard trimmings after major storms at no cost to the residents of the City of Oglesby; and

WHEREAS, the City of Oglesby desires to continue to provide residents of the City of Oglesby with semi-annual tree branch and yard trimming disposal as well as additional disposal caused by adverse weather conditions at no cost to the residents of the City of Oglesby, but the City of Oglesby cannot continue to pick up tree branches and yard trimmings deposited on the city property by residents outside of the designated time in the spring and fall of the year and after major storm events; and

WHEREAS, any resident of the City of Oglesby who deposits tree branches and yard trimmings on city property for employees of the City of Oglesby to remove outside of the designated times set forth in this ordinance, shall be subject to charges for this service as set forth in this ordinance; and

WHEREAS, Section 11-19-5 of the Illinois Municipal Code (65 ILCS 5/11-19-5) authorizes Illinois cities to provide for methods of removal of garbage, including refuse which includes the

definition of tree branches and yard trimmings; and

WHEREAS, Section 11-19-4 (65 ILCS 5/11-19-4) authorizes the City of Oglesby to assess a service charge for the removal of refuse; and

WHEREAS, the corporate authorities of the City of Oglesby deem it to be in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to adopt fees and charges for the removal of tree branches and yard trimmings from the public right-ofway.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The recitals contained in the preamble to this ordinance are restated and incorporated by reference as if set out in full herein.
- 2. If any resident of the City of Oglesby who deposits tree branches and yard trimmings on City of Oglesby property, with the expectation that the City of Oglesby will dispose of the tree branches and yard trimmings, at any time other than the dates set forth for the semi-annual disposal of these items or any time after a major storm event, shall be charged a sum of \$50.00 for the removal of the tree branches and yard trimmings by Oglesby city employees.
- 3. The fee established with this ordinance shall be added to a resident's monthly utility bill from the City of Oglesby and shall be payable in accordance with the provisions set forth for the payment of electrical utility bills in the Oglesby City Code.
- 4. Paragraph 6 of Appendix B Service Charge and Fee Schedule of Title 8, Health and Safety of Chapter 38, Garbage, Refuse and Recycling shall be deleted in its entirety.
- 5. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
