ORDINANCE NO. 1113-040820

AN ORDINANCE APPOINTING AN INTERIM CHIEF OF POLICE
FOR THE CITY OF OGLESBY

WHEREAS, Oglesby Police Chief James Knoblauch is scheduled to retire effective May 1, 2020; and

WHEREAS, the first candidate selected to fill the position of Chief of Police of the City of Oglesby has declined the offer to serve the City of Oglesby in this capacity; and

WHEREAS, the Illinois Association of Chiefs of Police have developed an Interim Chief of Police service identified as the Illinois Association of Chiefs of Police Linebacker Program ("Linebacker Program"); and

WHEREAS, the Linebacker Program is designed to provide a municipality with an interim or substitute Chief of Police who fills, on a short term basis, the vacancy created by the departure of a police department's Chief Executive Officer; and

WHEREAS, the objective of the Linebacker Program is to provide short-term council, experience and support to manage a municipal police department until a permanent replacement can be selected; and

WHEREAS, any individual serving in the Linebacker Program must have served as a Chief of Police or Public Safety Director in the State of Illinois and have been an active member of the Illinois Association of Chiefs of Police; and

WHEREAS, the City of Oglesby has authority to establish police departments and staff police departments pursuant to Section 11-1-1 of the Illinois Municipal Code (65 ILCS 5/11-1-1 (2018)); and

WHEREAS, the Corporate Authorities of the City of Oglesby deem it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to utilize the Illinois Association of Chiefs of Police Linebacker Program for the appointment of an interim police chief for the City of Oglesby.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are restated and reincorporated by reference as if set out in full herein.

2. The City of Oglesby hereby desires to appoint Doug Hayse as interim Chief of Police for the City of Oglesby pursuant to the Illinois Association of Chiefs of Police Linebacker Program.

3. Oglesby Mayor Dominic Rivara hereby appoints Doug Hayse as interim Chief of Police for the City of Oglesby pursuant to the Illinois Association of Chiefs of Police Linebacker Program subject to approval and authorization from the Oglesby City Council to confirm this appointment.

4. Doug Hayse will begin his work as Interim Oglesby Chief of Police on April 9, 2020.

5. The appointment of Doug Hayse as Interim Chief of Police for the City of Oglesby shall commence April 9, 2020 and shall terminate, unless otherwise extended by the City of Oglesby, on October 9, 2020.

6. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
