ORDINANCE NO. 1115-052820

AN ORDINANCE APPROVING A CONTRACT WITH PUTNAM COUNTY PAINTING,
INC. TO REPAINT OGLESBY WATER TOWER

WHEREAS, the City of Oglesby previously advertised for bids for the repainting and recoating of the west water tower in the City of Oglesby; and

WHEREAS, the contractor's estimate for this work was \$240,000.00 and the lowest bid received by the City of Oglesby was \$285,575.00, which was \$45,575.00 more than the engineer's estimate for the project; and

WHEREAS, at the May 18, 2020 meeting of the Oglesby City Council, the Oglesby City Council rejected all of the bids received for the west water tower repainting and recoating project; and

WHEREAS, subsequent to the City of Oglesby's rejection of all bids, the City of Oglesby modified and revised the scope of the work for this project; and

WHEREAS, the City of Oglesby has obtained an estimate from Putnam County Painting, Inc. to repaint and recoat the west water tower for the City of Oglesby pursuant to the modified and revised specifications in the amount of two hundred twenty thousand dollars (\$220,000.00); and

WHEREAS, certain legislation adopted by the State of Illinois will require significant additional and more expensive repainting and recoating procedures for any water tower repainting and recoating work after June 1, 2020 which would increase the cost of the recoating and repainting contract above and beyond the original \$240,000.00 engineer's estimate for the project; and

WHEREAS, Section 4-5-11 of the Illinois Municipal Code (65 ILCS 5/4-5-11 (2018)) authorizes a municipality to enter into any work of other public improvement in excess of \$25,000.00 without competitive bids if the contract for the improvement is approved by a vote of 4 of the 5 members of the Oglesby City Council; and

WHEREAS, the City of Oglesby deems it to be in the best financial and public health and safety interest of the residents of the City of Oglesby to accept the painting estimate from Putnam County Painting, Inc. in the amount of two hundred twenty thousand dollars (\$220,000.00) for this project.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are incorporated by reference as if set out in full herein.

2. The City of Oglesby is hereby authorized to enter into a contract with Putnam County Painting, Inc. to repaint and recoat the City of Oglesby west water tower in accordance with the estimate from Putnam County Painting, Inc. in the amount of two hundred twenty thousand dollars (\$220,000.00) pursuant to the estimate attached to this ordinance, marked as Exhibit A and incorporated by reference as if set out in full herein.

3. The Mayor of the City of Oglesby and the Clerk of the City Clerk of the City of Oglesby are hereby authorized to enter into and approve the contract for the repainting and recoating of the City of Oglesby's west water tower with Putnam County Painting, Inc. in the amount of two hundred twenty thousand dollars (\$220,000.00) and to sign all documents required to finalize this estimate.

4. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
