AN ORDINANCE AUTHORIZING THE CITY OF OGLESBY  
TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH  
THE CENTRAL ILLINOIS POLICE TRAINING CENTER

WHEREAS, the City of Oglesby currently receives most of its police department training from the Illinois Law Enforcement Training and Standards Board; and

WHEREAS, most of the City of Oglesby's training has been conducted through the Illinois Law Enforcement and Training Standards Board Mobile Training Unit #5 ("MTU #5") in Princeton, Illinois; and

WHEREAS, the MTU #5 is closing July 1, 2020 and MRU #5 is being consolidated with MTU #7 located in Peoria, Illinois which is the Illinois Law Enforcement Training Standards Board Central Illinois Police Training Center; and

WHEREAS, the City of Oglesby desires to enter into an intergovernmental cooperation agreement with the Central Illinois Police Training Center; and

WHEREAS, Article V, Section 10 of the Constitution of the State of Illinois and the Intergovernmental Cooperation Act (5 ILCS 220/1 et. seq.) authorizes the City of Oglesby to enter into this agreement; and

WHEREAS, the City of Oglesby deems it to be in the best interest of the public health and safety of the residents of the City of Oglesby to enter into this agreement.

NOW, THEREFORE, be it ordained by the City Council of the City of Oglesby, LaSalle County, Illinois as follows:

1. The recitals contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.

2. The City of Oglesby hereby agrees to enter into an intergovernmental contract with the Illinois Law Enforcement Training and Standards Board, Central Illinois Police Training Center which intergovernmental agreement is attached to this ordinance, marked as Exhibit A and incorporated by reference as if set out in full herein.

3. The City of Oglesby hereby authorizes either Oglesby Mayor Dominic Rivara or Oglesby Police Chief Doug Hayse to sign the intergovernmental agreement on behalf of the City of Oglesby.

3. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
