AN ORDINANCE AMENDING CHAPTER 28, WATER SERVICE REGULATIONS, OF TITLE 13, PUBLIC UTILITIES, OF THE OGLESBY CITY CODE

WHEREAS, Section 13.28.260 of the Oglesby City Code provides for temporary water service for contractors and builders for water to be used during construction work; and

WHEREAS, the City of Oglesby desires to establish a rate to be charged to businesses not based in the City of Oglesby desiring to purchase bulk amounts of water from the City of Oglesby; and

WHEREAS, Section 11-125-3 of the Illinois Municipal Code (65 ILCS 5/11-125-3 (West 2018)) authorizes the City of Oglesby in impose rates for the use and supply of public water by the City of Oglesby; and

WHEREAS, the City of Oglesby deems it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to adopt this ordinance establishing water rates for businesses outside the City of Oglesby desiring to purchase bulk water from the City of Oglesby.

NOW, THEREFORE, be it ordained by the City Council of the City of Oglesby, LaSalle County, Illinois as follows:

- 1. The recitals contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.
- 2. Section 13-28-260 of Chapter 13.28, Water Service and Regulations, of Title 13, Public Utilities, the City of Oglesby shall be amended to read as follows:

13.28.260 Temporary service Swing meters/Non-Resident Commercial Bulk Water Purchases.

Applications shall be made to the City Clerk for any temporary service desired by contractors and builders for water to be used in construction work. Upon deposit of ten dollars (\$10.00), the City shall furnish a swing meter to be used on such service. The charges for such service shall be the same rates as other services, including minimum charges.

Any non-resident commercial customer desiring to purchase water in bulk from the City of Oglesby shall be charged the rural rate Level One for non-residential customers for any volume of water the customer may request. Additionally, any commercial customer desiring to purchase bulk water from the City of Oglesby who does not operate a business in the City of Oglesby shall, in addition to paying the water rates set forth herein, also receive permission from the Oglesby commissioner having charge of the water department prior to making any bulk purchase of water from the City of Oglesby. The commissioner having charge of the water department shall have the right, in his or her sole discretion, to either allow or not allow the purchase of bulk water from the City of Oglesby by a non-resident private business.

- 3. All of the remaining provisions of Chapter 13.28 Water Service and Regulations, of Title 13, Public Utilities, of the Oglesby City Code not otherwise amended or modified by this ordinance shall remain in full force and effect.
- 4. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
