AN ORDINANCE ADOPTING A HAZARD MITIGATION PLAN FOR THE CITY OF OGLESBY

WHEREAS, the City of Oglesby desires to adopt a Hazard Mitigation Plan to cover actions which the City of Oglesby would take in the event of any natural disaster or other emergency; and

WHEREAS, Section 11-1-1 of the Illinois Municipal Code (65 ILCS 5/11-1-1 (West 2018)) authorizes Illinois municipalities to pass and enforce all necessary police ordinances; and

WHEREAS, Section 11-1-6 of the Illinois Municipal Code (65 ILCS 5/11-1-6 (West 2018)) authorizes the mayors of each Illinois municipality to exercise emergency powers; and

WHEREAS, Section 11-59-1 of the Illinois Municipal Code (65 ILCS 5/11-59-1 (West 2018)) authorizes the corporate authorities of each Illinois municipality to provide for continuity of administration and legislative functions of the municipality in the event of an attack on the United States; and

WHEREAS, by implication, each of the foregoing provisions of the Illinois Municipal Code authorize the City of Oglesby to adopt a Hazard Mitigation Plan; and

WHEREAS, the corporate authorities of the City of Oglesby deem it to be in the best interest in the public health, safety and welfare of the residents of the City of Oglesby to adopt a Hazard Mitigation Plan.

NOW, THEREFORE, be it ordained by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois as follows:

1. The recitals contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.

2. The City of Oglesby hereby adopts the Oglesby Illinois Hazard Mitigation Plan in the form and substance as set forth in Exhibit A, attached to this ordinance, and incorporated by reference as if set out in full herein.

3. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
