AN ORDINANCE AMENDING CHAPTER 10.24, STOPPING, STANDING AND PARKING, OF TITLE 10, VEHICLES AND TRAFFIC, OF THE OGLESBY CITY CODE

WHEREAS, the corporate authorities of the City of Oglesby deem it to be in the best interest in the public health, safety and welfare of the residents of the City of Oglesby to provide rules and regulations regarding the parking of vehicles along portions of Walnut Street within the corporate limits of the City of Oglesby; and

WHEREAS, Section 11-8-2 of the Illinois Municipal Code (65 ILCS 5/11-80-2 (West 2018)) authorizes the corporate authorities of the City of Oglesby to regulate streets and parking.

NOW, THEREFORE, be it ordained by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois as follows:

- 1. The recitals contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.
- 2. Section 10.24.073(a)(1) and Section 10.24.073(B)(1) shall be hereby amended to read as follows:

10.24.073(A)(1)

It is unlawful to park any vehicle or to permit a vehicle to remain parked, on the north side of Walnut Street from the intersection of Dale Avenue and for a distance of one hundred sixty (160') feet east for a period longer than three consecutive hours, except on Sundays and holidays. The term holiday shall include those days designated by Act of Congress or of the State Legislature of by the city council as holidays;

10.24.073(B)(1)

It is unlawful to park any vehicle or to permit a vehicle to remain parked on the north and south sides of Walnut Street from the intersection of School Avenue to the intersection of Watson Avenue for a period of longer than three consecutive hours, except on Sundays and holiday, from the hours of nine a.m. to six p.m. The term holiday shall include those days designated by Act of Congress or of the State Legislature or by the city council;

3. All of the remaining provisions of Section 10.24.073, including any additional sub-paragraphs of said section, not otherwise amended by this ordinance shall remain in full force and effect.

4. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
