ORDINANCE NO. 1136-110220

AN ORDINANCE AMENDING CHAPTER 10.24 - STOPPING, STANDING AND PARKING  
OF TITLE 10 - VEHICLES AND TRAFFIC OF THE OGLESBY CITY CODE

WHEREAS, the corporate authorities of the City of Oglesby deem it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to amend Section 10.24.050 of the Oglesby City Code which prohibits parking on certain streets within the corporate limits of the City of Oglesby; and

WHEREAS, Section 11-80-2 of the Illinois Municipal Code (65 ILCS 5/11-80-2 (West 2018)) authorizes the corporate authorities of each municipality to regulate the use of streets.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are incorporated herein and restated as if set out in full.

2. Section 10.24.050 of the Oglesby City Code shall be amended to prohibit parking on the following streets:

21. There shall be no parking permitted on the North side of First Street
22. There shall be no parking permitted on the North side of Second Street
23. There shall be no parking permitted on the South side of Third Street
24. There shall be no parking permitted on the East side of Dale Avenue
25. There shall be no parking permitted on the West side of South Glen Street
26. There shall be no parking permitted on the North side of Durant Street
27. There shall be no parking permitted on the West side of Hazen Street

3. All of the remaining provisions of Section 10.24.050 of Chapter 10.24 - Stopping, Standing and Parking of Title 10 - Vehicles and Traffic of the Oglesby City Code not otherwise amended by this ordinance shall remain in full force and effect.

4. This ordinance will be in full force and affect after its passage, approval, and publication in pamphlet form as provided by law.
