ORDINANCE NO. 1138-111620

AN ORDINANCE AUTHORIZING THE EXECUTION OF A MANAGEMENT AND SUPERVISION AGREEMENT FOR WASTE WATER TREATMENT PLANT, AND WATER TREATMENT PLANT FOR THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS

WHEREAS, the Corporate Authorities of the City of Oglesby deem it to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby to enter into an agreement with Total Environmental Service Technologies, Inc., and Illinois Corporation, (hereinafter "TEST") in the form and substance as set forth in Exhibit A entitled Management and Supervision Agreement for Waste Water Treatment Plant, and Water Treatment Plant for the City of Oglesby, (hereinafter "AGREEMENT"); and

WHEREAS, the City of Oglesby desires to enter into a contract with TEST whereby TEST will perform certain designated services for the City of Oglesby as set forth in the attached AGREEMENT; and

WHEREAS, the City of Oglesby desires to hire TEST to perform designated water and waste water services for the City of Oglesby as set forth in the attached AGREEMENT; and

WHEREAS, the Corporate Authorities of the City of Oglesby have determined that TEST can provide services to the City of Oglesby as set forth in the AGREEMENT at a lower cost to the City of Oglesby than the City of Oglesby would incur by using City employees to perform the services to be undertaken by TEST in accordance with the enclosed AGREEMENT; and

WHEREAS, Section 11-124-1 of the Illinois Municipal Code (65 ILCS 5/11-124-1) authorizes municipalities to enter into contracts for the supply of water for a period of up to 40 years; and

WHEREAS, Section 11-137-1 of the Illinois Municipal Code (65 ILCS 5/11-137-1) authorizes municipalities to enter into contracts for a supply of water for public use, and for sewerage for drainage and sanitary purposes for up to 30 years, and by implication authorizes municipalities to contact with third-party suppliers such as TEST to provide certain services for a municipality.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are incorporated by reference as if set out in full herein.

2. The City of Oglesby hereby agrees to enter into a contract with Total Environmental Service Technologies, Inc. (hereinafter "TEST") in the form and substance as set forth in Exhibit A attached hereto and incorporated by reference as if set out in full herein entitled Management and Supervision Agreement for Waste Water Treatment Plant and Water Treatment Plant for the City of Oglesby (hereinafter "AGREEMENT").

3. The Mayor of the City of Oglesby and the City Clerk of the City of Oglesby are authorized to sign the AGREEMENT on behalf of the City of Oglesby.

4. This ordinance shall be in full force and effect from and after its passage, approval and due publication in pamphlet form as provided by law.
