AN ORDINANCE AUTHORIZING THE EXECUTION OF AN AGREEMENT FOR STUDY SERVICES
BETWEEN THE CITY OF OGLESBY AND AMEREN ILLINOIS COMPANY

WHEREAS, the City of Oglesby is a member of the Illinois Electrical Agency ("IMEA"); and

WHEREAS, the IMEA, on behalf of the City of Oglesby and the City of Peru, has requested that Ameren Illinois Company ("Ameren") undertake a study to determine the feasibility of providing both the City of Oglesby and the City of Peru with a 34.5 kV delivery point for the City of Oglesby near the City of Oglesby's Mallick Road substation; and

WHEREAS, the City of Oglesby deems it to be in the best interest of the residents of the City of Oglesby to enter into the study agreement with Ameren; and

WHEREAS, the City of Oglesby is authorized to enter into the study agreement pursuant to Section 11-119.1-2 of the Illinois Municipal Code (65 ILCS 5/11-119.1-2 (West 2018)).

NOW, THEREFORE, be it ordained by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois as follows:

1. The recitals contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.
2. The City of Oglesby hereby agrees to enter into an Agreement for Study Services with Ameren Illinois Company, the Illinois Municipal Electrical Agency, and the City of Peru in accordance with the Agreement for Study Services attached to this ordinance, marked as Exhibit A, and incorporated by reference as if set out herein.
3. That the Mayor shall be authorized to sign the Agreement for Study Services on behalf of the City of Oglesby.
4. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
