AN ORDINANCE AMENDING ORDINANCE 1152-021621 RENAMING ROEBUCK STREET
IN THE CITY OF OGLESBY FROM SUNSET STREET TO SUNSET BOULEVARD

WHEREAS, the corporate authorities of the City of Oglesby previously passed Ordinance 1152-021621 renaming Roebuck Street in the City of Oglesby to Sunset Street; and

WHEREAS, no homes or businesses have been built on that portion of Roebuck Street situated west of the intersection of Roebuck Street and Marquette Avenue; and

WHEREAS, the corporate authorities of the City of Oglesby desire to amend Ordinance 1152-021621 so that portion of Sunset Street, previously known as Roebuck Street situated west of the intersection of Sunset Street and Marquette Avenue, be known as Sunset Boulevard; and

WHEREAS, Section 11-80-19 of the Illinois Municipal Code (65 ILCS 5/11-80-19 (West 2018)) authorizes municipalities to change the name of any street within a municipality; and

WHEREAS, the mayor and commissioners of the City of Oglesby deem it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to amend Ordinance 1152-021621 to correctly rename that portion of Sunset Street situated west of its intersection with Marquette Avenue as Sunset Boulevard.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble of this ordinance are incorporated by reference and adopted herein.
2. Ordinance 1152-021621 shall be amended by renaming Sunset Street, previously known as Roebuck Street, west of its intersection with Marquette Avenue, as Sunset Boulevard.
3. The Clerk of the City of Oglesby is directed to send a certified copy of this Ordinance to the LaSalle County Clerk, attention Election Department, and to the United States Postal Service in Oglesby, Illinois notifying both the LaSalle County Clerk and the United States Postal Service of the change in this street.
4. Street signs reflecting the name change from Sunset Street to Sunset Boulevard shall be installed as soon as practicable. All public records shall be corrected to reflect the street name

changes authorized by the Ordinance.

5. This Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
