**AN ORDINANCE ESTABLISHING THE SALARY
AND BENEFITS TO BE PAID TO THE OGLESBY CITY CLERK**

WHEREAS, the City of Oglesby desires to establish the wage and benefits to be provided to the Oglesby City Clerk; and

WHEREAS, Section 4-6-2 of the Illinois Municipal Code (65 ILCS 5/4-6-2) authorizes the City of Oglesby to set compensation for all officers and employees of the City of Oglesby; and

WHEREAS, the Mayor and City Council of the City of Oglesby deem it to be in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to adopt an ordinance setting the salary and benefits to be paid to the Oglesby City Clerk; and

WHEREAS, the Oglesby City Clerk has agreed to accept additional duties concerning economic development for the City,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are restated and

incorporated by reference as if set out in full herein.

2. For the period from May 1, 2021, through April 30, 2022, the City Clerk of the City of Oglesby shall be paid an hourly wage of \$27.00 per hour and shall receive benefits as provided by for in the Labor Agreement entered into between the City of Oglesby and the International Brotherhood of Electrical Workers Local 51, as amended from time to time, covering that period of time.

3. For the period from May 1, 2022, to April 30, 2023, the City Clerk shall be paid an hourly wage of \$27.88 per hour and receive benefits as provided for in the Labor Agreement entered into between the City of Oglesby and the International Brotherhood of Electrical Workers Local 51, as amended from time to time, covering that period of time.

4. For the period from May 1, 2023, to April 30, 2024, the City Clerk shall be paid an hourly wage of \$28.78 per hour and receive benefits as provided for in the Labor Agreement entered into between the City of Oglesby and the International Brotherhood of Electrical Workers Local 51, as amended from time to time, covering that period of time.

5. For the period from May 1, 2024, to April 30, 2025, the City Clerk shall be paid an hourly wage of \$29.72 per hour and receive benefits as provided for in the Labor Agreement entered into between the City of Oglesby and the International Brotherhood of Electrical Workers Local 51, as amended from time to time, covering that period of time.

7. The hourly wage for the City Clerk specified in paragraph "2." of this Ordinance shall be paid retroactive to May 1, 2021.

8. This Ordinance shall be in full force and effect from and after its passage, approval and due publication in pamphlet form as provided by law.

9. The City Clerk is hereby instructed to publish this Ordinance in pamphlet form as required by law.
