**AN ORDINANCE ESTABLISHING WAGES
TO BE PAID TO CERTAIN CITY EMPLOYEES
NOT COVERED BY A COLLECTIVE BARGAINING AGREEMENT**

WHEREAS, the City Council of the City of Oglesby desires to establish wages for certain City employees that are not covered by a collective bargaining agreement; and

WHEREAS, Section 10-4-1 of the Illinois Municipal Code (65 ILCS 5/10-4-1) provides the City of Oglesby with broad authority to provide by ordinance with regard to all municipal officers and employees of the City; and

WHEREAS, the Mayor and City Council of the City of Oglesby deem it to be in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to adopt an ordinance setting the wages for certain City employees not covered by a collective bargaining agreement,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are restated and incorporated by reference as if set out in full herein.

2. The following employees shall be compensated in the following amounts:

Part time assistant City clerk	\$17.00/hour
Assistant park's employee	\$15.00/hour
Part time summer help	\$11.00/hour
Pool manager	\$15.00/hour
Assistant pool manager	\$11.50/hour
Lead lifeguard	\$11.25/hour
Pool worker	\$11.00/hour

3. This Ordinance shall be in full force and effect from and after its passage, approval and due publication in pamphlet form as provided by law.

4. The City Clerk is hereby instructed to publish this Ordinance in pamphlet form as required by law.
