# AN ORDINANCE AMENDING & ESTABLISHING COMPENSATION FOR CERTAIN EMPLOYEES. OF THE OGLESBY FIRE DEPARTMENT

WHEREAS, the City of Oglesby employs a Fire Chief and other employees in the Oglesby City Fire Department; and

WHEREAS, the City Council of the City of Oglesby desires to establish amended wage rates for the Fire Chief and other employees in said Department which are not covered by a collective bargaining agreement; and

WHEREAS, Section 10-4-1 of the Illinois Municipal Code (65 ILCS 5/10-4-1) provides the City of Oglesby with broad authority to provide by ordinance with regard to all municipal officers and employees of the City; and

WHEREAS, the Mayor and City Council of the City of Oglesby deem it to be in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to adopt an ordinance establishing amended wage rates for the Fire Chief and other employees in said Department not covered by a collective bargaining agreement as stated herein,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY
OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1:** RECITALS: The recitals contained in the preamble to this Ordinance are restated and incorporated by reference as if set out in full herein.

SECTION 2. WAGE RATES: Effective and retroactive to May 1, 2021, the following employees shall be compensated in the following amounts:

Position: Rate

Fire Chief \$500.00/month

Firewoman/Fireman \$28.50/call

Commencing May 1, 2022, and on May 1<sup>st</sup> of each of the two successive May 1<sup>sts</sup> thereafter, to end on May 1, 2024, said employees shall receive a three percent (3%) annual rate increase.

In addition, if a Firewoman/Fireman is attending to a fire/rescue call for more than four (4) consecutive hours, said Firewoman/Fireman shall be paid for an additional call at the rate specified above. Fire Department personnel shall also be paid the per call rate for fire training twelve (12) times per year, and said Fire Department employee must report said training to the City Council and City Clerk through the Commissioner of that Department.

**SECTION 3.** SUPERSEDING PRIOR WAGE RATES: The rates set forth in this ordinance shall supersede any prior wage rates set forth for the positions and persons specified herein, from an after the effective date hereinabove specified.

SECTION 4. EFFECTIVE DATE: This Ordinance shall be in full force and effect

SECTION 5. PUBLICATON: The City Clerk is hereby instructed to publish this

Ordinance in pamphlet form as required by law.
