ORDINANCE NO. 1189-030722

AN ORDINANCE REPEALING AND REPLACING THE NET METERING POLICY OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS

WHEREAS, the corporate authorities of the City of Oglesby, LaSalle County, Illinois have previously approved a Net Metering Policy for the City of Oglesby so as to allow self-generating customers to connect to its electrical distribution system; and

WHEREAS, due to a change in Illinois law, the City is required to update its Net Metering Policy; and

WHEREAS, the corporate authorities of the City of Oglesby, LaSalle County, Illinois, deem it to be in the best interest of the residents of the City of Oglesby to repeal and replace its existing Net Metering Policy so as to comply with Illinois law,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois, as follows:

SECTION 1- RECITALS

The recitals contained in the preamble to this Ordinance are restated as if set out in full herein.

SECTION 2 – AUTHORIZATION TO REPEAL AND REPLACE NET METERING POLCY

The existing Net Metering Policy of the City of Oglesby is hereby repealed and the Net Meting Policy set forth as Exhibit A and attached to this Ordinance is hereby approved.

SECTION 3 – PUBLICATION

This Ordinance shall be in full force and affect after its passage, approval, and publication in pamphlet form as provided by law.
