**AN ORDINANCE AUTHORIZING THE APPROVAL OF
A FACILITY LEASE AGREEMENT BETWEEN THE CITY OF OGLESBY
AND THE BENEVOLENT AND PROTECTIVE ORDER OF ELKS,
OGLESBY, ILLINOIS, LODGE #2360**

WHEREAS, the City of Oglesby sponsors various events throughout the year at or in the area of the Benevolent and Protective Order of Elks, Oglesby, Illinois, Lodge #2360; and

WHEREAS, the City of Oglesby desires to enter into a Facility Lease Agreement for those various events with the Benevolent and Protective Order of Elks, Oglesby, Illinois, Lodge #2360, in the form and substance as set forth in Exhibit A attached to this Ordinance; and

WHEREAS, Section 11-54.1-3 of the Illinois Municipal Code (65 ILCS5/11-54.1-3) authorizes municipalities to conduct events, which are temporarily set up or conducted in a public place or upon any private premises accessible to the public; and

WHEREAS, the City of Oglesby intends to use property owned by the Benevolent and Protective Order of Elks Oglesby Illinois Lodge #2360 for various events throughout the year and

WHEREAS, the corporate authorities or the City of Oglesby deem it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to enter into an agreement with the Benevolent and Protective Order of Elks, Oglesby, Illinois, Lodge #2360 regarding the use of their facilities for those events.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois as follows:

1. The recitals contained in the preamble to this Ordinance are restated as if set out in full herein.

2. The City of Oglesby is hereby authorized to enter into a Facility Lease Agreement between the City of Oglesby and the Benevolent and Protective Order of Elks, Oglesby, Illinois, Lodge #2360, in the form and substance as set forth in Exhibit A, attached to this Ordinance and incorporated by reference as if set out in full herein.

3. The Mayor of the City of Oglesby and the City Clerk of the City of Oglesby are hereby authorized to sign the Facility Lease Agreement on behalf of the City of Oglesby.

4. In addition to the obligations set forth in the attached Facility Lease Agreement, the City of Oglesby hereby agrees to name the Benevolent and Protective Order of Elks, Oglesby Illinois Lodge #2360, as an additional insured on the City of Oglesby's general liability insurance policy. The Oglesby City Clerk is directed to obtain a Certificate of Insurance naming the Benevolent and Protective Order of Elks, Oglesby, Illinois, Lodge #2360, as an additional insurance on the City of Oglesby's general liability insurance policy after the adoption of this Ordinance.

5. This Ordinance shall be in full force and affect after its passage, approval, and publication in pamphlet form as provided by law.
