#### **ORDINANCE NO. 1180-120621**

## AN ORDINANCE ESTABLISHING A BOARD OF DIRECTORS FOR THE AMBULANCE SERVICE FOR THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS

WHEREAS, the City of Oglesby has made a commitment to provide ambulance services for the health and well-being of its residents and, to carry out that commitment, has established the Oglesby Ambulance Service; and

WHEREAS, the corporate authorities of the CITY OF OGLESBY deem it to be in the best interest of the public health, safety and welfare of the residents of the CITY OF OGLESBY to establish an Ambulance Service Board of Directors to supervise and operate the Oglesby Ambulance Service

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Commissioners of the City of Oglesby, LaSalle Count, Illinois as follows:

#### SECTION 1- RECITALS

The recitals contained in the preamble to this Ordinance are restated as if set out in full herein.

## <u>SECTION 2 - BOARD OF DIRECTORS - ESTABLISHED</u>

An Ambulance Service Board of Directors is hereby created, which Board shall consist of seven (7) members. Two (2) of the members shall be non-voting members of the Board, namely the City of Oglesby Fire Chief and the City of Oglesby Ambulance Director. The five voting members of the Board shall consist of the Commissioner of Public Health & Safety of the City of Oglesby and four additional members whose appointment shall be recommended by the Mayor and approved by the City Council.

#### SECTION 3 – BOARD OF DIRECTORS – COMPENSATION

The members of the Ambulance Service Board of Directors shall serve without compensation.

#### SECTION 4 - BOARD OF DIRECTORS - TERM OF OFFICE AND VACANCIES

The four appointed voting members of the Board shall serve for two (2) year terms, or until their successor is appointed (whichever occurs earlier), except that the members of the first Board shall be appointed so that the term of two (2) members shall terminate in one (1) year and the term of two (2) members shall terminate in two (2) years. If a vacancy occurs in the office of any Board member, the appointment of a successor member to serve the remainder of that office's unexpired term shall be recommended by the Mayor and approved by the City Council. The Commissioner of Public Health & Safety shall be a member of the Board for the duration of her or his four (4) year elected term. The non-voting members of the Board, namely the Fire Chief and Ambulance Director, shall be members of the Board so long as they hold their positions.

#### SECTION 5 – BOARD OF DIRECTORS – ELECTION OF OFFICERS

Immediately after the appointment of the members of the Ambulance Service Board of Directors, the members shall meet and organize by electing one of its members as Chairman and other such officers as the members deem necessary. Thereafter, the annual election of officers shall be held at the first meeting of the Board after May 1<sup>st</sup> of each year.

#### SECTION 6 - BOARD OF DIRECTORS - EXPIRATION OF TERM

The term of office for each of the members of the Ambulance Service Board of Directors shall expire on April 30<sup>th</sup> in the year in which their appointment ends.

## SECTION 7 - BOARD OF DIRECTORS - POWERS AND DUTIES

The Ambulance Service Board of Directors is vested with the power to all carry into effect all ordinances of the City with regard to the regulation and operation of the Oglesby Ambulance Service. It shall supervise and assist the Ambulance Director. It shall recommend to the City Council, for adoption by ordinance or resolution, such rules, regulations and rates for services furnished as are necessary for the orderly direction and management of the Oglesby Ambulance Service. It shall have authority to review the policies and practices of the Oglesby Ambulance Service and recommend any changes to either that it deems to be necessary or in the interest of "best practices". It shall report to the Commissioner of Public Health & Safety and may recommend such audits as it deems necessary.

## **SECTION 8- PUBLICATION**

This Ordinance shall be in full force and affect after its passage, approval, and publication in pamphlet form as provided by law.
