ORDINANCE NO. 1068-060319

AN ORDINANCE AMENDING CHAPTER 2.57 PLAN COMMISSION OF TITLE 2,
ADMINISTRATION AND PERSONNEL, OF THE OGLESBY CITY CODE

WHEREAS, Section 2.57.020 lists the members of the Oglesby Plan Commission;
and

WHEREAS, the corporate authorities of the City of Oglesby desire to substitute the
Commissioner of Accounts and Finances for the Commissioner of Public Improvements
as ex officio members of the Plan Commission; and

WHEREAS, Section 11-12-4 of the Illinois Municipal Code (65 ILCS 5/11-12-4)
authorizes the creation of a Plan Commission and authorizes the Mayor to appoint
members to the Plan Commission.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Commissioners of the
City of Oglesby, LaSalle County, Illinois as follows:

1. The recitals contained in the preamble to this ordinance are incorporated by
reference herein.

2. Section 2.57.020 of Chapter 2.57 Plan Commission of Title 2, Administration
and Personnel, of the Oglesby City Code shall be amended to read as follows:

2.57.020 Members. The Plan Commission shall consist of eleven (11) members
to include the following. The Mayor and the Commissioner of Accounts and
Finances shall be members ex officio of the Plan Commission, with power to vote
and nine (9) other members, citizens of the city, appointed by the Mayor, on the
basis of their particular fitness for their duty on the Plan Commission and subject to
the approval of the City Council.

3. All of the remaining provisions of Chapter 2.57 Plan Commission, of Title 2,
Administration and Personnel, not otherwise amended by this ordinance shall remain in

full force and effect.

4. This ordinance will be in full force and affect after its passage, approval and publication in pamphlet form as provided by law.
