ORDINANCE NO. 1077-081919

AN ORDINANCE ESTABLISHING A SPEED LIMIT, WEIGHT LIMIT AND PROHIBITING DUMPING ON THE ED HAND HIGHWAY OGLESBY CANOE LANDING ACCESS ROAD

WHEREAS, the City of Oglesby has paved an access road from Ed Hand Highway to the Oglesby canoe landing in order to provide safe passage for vehicles travelling from Ed Hand Highway to the Oglesby canoe landing adjacent to the Vermilion River in Oglesby, Illinois; and

WHEREAS, the City of Oglesby desires to establish a speed limit for this road and a weight limit for this road; and

WHEREAS, the City of Oglesby desires to prohibit any dumping of garbage or refuse material in the area of the canoe landing, except for disposal in receptacles provided for this purpose; and

WHEREAS, Section 11-40-1 of the Illinois Municipal Code (65 ILCS 5/11-40-1) authorizes the City of Oglesby to regulate and establish speed limits for vehicles travelling within the corporate limits of the City of Oglesby; and

WHEREAS, Section 11-40-1 (65 ILCS 5/11-40-1) also provides that the City of Oglesby may regulate vehicles conveying loads within the municipality and by implication, authorizes the City of Oglesby to establish weight limits for certain roads maintained by the City of Oglesby; and

WHEREAS, the City of Oglesby has constructed an access road from Ed Hand Highway to the Oglesby canoe landing adjacent to the Vermilion River within the corporate limits of the City of Oglesby, LaSalle County, Illinois; and

WHEREAS, in order to preserve the access road from Ed Hand Highway to the Oglesby canoe landing adjacent to the Vermilion River, the Mayor and Commissioners of the City of Oglesby deem it to be in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to establish a speed limit and a weight limit for this access road; and

WHEREAS, the City of Oglesby desires to prohibit the dumping of trash or other refuse on the property owned by the City of Oglesby adjacent to the access road between Ed Hand Highway and Oglesby canoe landing, except for waste and trash deposited in receptacles provided for this purpose; and

WHEREAS, Section 11-19-5 of the Illinois Municipal Code (65 ILCS 5/11-19-5) authorizes the City of Oglesby to provide methods for the disposition of garbage and refuse.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are incorporated by reference as if set out in full herein.

2. The speed limit for the access road between Ed Hand Highway and the Olgesby canoe landing adjacent to the Vermilion River within the corporate limits of the City of Oglesby shall be set at ten (10) miles per hour.

3. The weight limit for the access road between Ed Hand Highway and the canoe landing adjacent to the Vermilion River within the corporate limits of the City of Oglesby shall be set at sixteen thousand (16,000) pounds.

4. It shall be unlawful for any individual to dump garbage or refuse along the access road from Ed Hand Highway to the canoe landing adjacent to the Vermilion River within the corporate limits of the City of Oglesby except for the disposal of garbage and refuse in receptacles provided for this purpose.

5. Any individual, business or corporation violating the weight limit imposed by the ordinance shall be subject to a fine of five hundred (\$500.00) dollars for each violation.

6. Any individual, corporation or business violating the ten (10) mile per hour speed limit provision provided for in this ordinance shall be guilty of a fine of one hundred (\$100.00) dollars.

7. Any individual, corporation or business violating the refuse disposal provisions of this ordinance shall be subject to a fine of five hundred (\$500.00) dollars for each occurrence.

8. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
