WHEREAS, the City Council (the "Council") of the City of Oglesby, LaSalle County, Illinois (the "City"), by ordinance adopted on the 5th day of April, 2010 (the "Ordinance"), did provide for the issuance of General Obligation Bonds (Alternate Revenue Source), Series 2010A and 2010B, not to exceed \$6,600,000, and the levy of a direct annual tax sufficient to pay the principal of and interest on said bonds; and

WHEREAS, pursuant to the Ordinance, the City has heretofore issued \$5,255,000 General Obligation Bonds (Alternate Revenue Source), Series 2010A, dated April 30, 2010, (the "Bonds"); and

WHEREAS, said Ordinance provides for a levy for the year 2019 in an amount of \$499,200.00 for the payment of principal and interest due on said obligations; and

WHEREAS, the City has Pledged Revenues (as defined in the Ordinance) on deposit in the Bond Fund available for the purpose of paying debt service on the bonds heretofore imposed by the 2019 levy; and

WHEREAS, such Pledged Revenues are hereby directed to be used for the purpose of paying debt service on the Bonds; and

WHEREAS, it is necessary and in the best interests of the City that the taxes hereto levied for the year 2019 to pay the Bonds be abated:

NOW, THEREFORE, Be It and It is Hereby Ordained by the City Council of the City of Oglesby, LaSalle County, Illinois, as follows:

Section 1. Abatement of Taxes. The amount of \$499,200.00 for the year 2019 for the payment of principal and interest due January 1, 2020 on said Series 2010A obligations are hereby abated.

Section 2. Filing or Ordinance. Forthwith upon the adoption of this Ordinance, the City Clerk of the Council shall file a certified copy hereof with the County Clerk and it shall be the duty of the County Clerk to abate said taxes levied for the year 2019 in accordance with the provisions hereof.

Section 3. Effective Date. This ordinance shall be in full force and effect forthwith upon its adoption.
