ORDINANCE NO. 1153-021621

AN ORDINANCE AUTHORIZING THE CITY OF OGLESBY TO ENTER INTO A
SECONDARY EMPLOYER INDEMNITY AND CONDITIONS AGREEMENT
WITH THE CITY OF PERU AND WITH THE CITY OF LASALLE

WHEREAS, the City of Oglesby desires to hire part time police officers who are full time police officers with the Peru Police Department and the LaSalle Police Department; and

WHEREAS, as a condition of part time employment, the City of Peru and the City of LaSalle require a local municipality desiring to hire full time Peru or LaSalle police officers for part time positions to enter into a Secondary Employment Indemnity and Conditions Agreement with the City of Peru and the City of LaSalle; and

WHEREAS, the Secondary Employment Indemnity and Conditions Agreement which the City of Oglesby intends to enter into with the City of Peru is attached hereto, marked as Exhibit A and incorporated by reference as if set out in full herein and the Secondary Employment Indemnity and Conditions Agreement which the City of Oglesby intends to enter into with the City of LaSalle is attached hereto, marked as Exhibit B and incorporated by reference as if set out in full herein;

WHEREAS, Section 10-4-1 of the Illinois Municipal Code (65 ILCS 5/10-4-1 (West 2018)) authorizes any municipality in the State of Illinois by provide by ordinance in regard to the relation between all municipal officers and employees in respect to each other, the municipality, the people, and by implication authorizes the City of Oglesby to enter into agreements to provide appropriate police protection for the residents of the City of Oglesby; and

WHEREAS, the City Council of the City of Oglesby deems it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to authorize the City of Oglesby to enter into the Secondary Employment Indemnity and Conditions Agreements.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.

2. The City of Oglesby hereby agrees to enter into the Secondary Employment Indemnity and Conditions Agreement with the City of Peru as set forth in Exhibit A attached to this ordinance as if set out in full herein; and

3. The City of Oglesby hereby agrees to enter into the Secondary Employment Indemnity and Conditions Agreement with the City of LaSalle as set forth in Exhibit B attached to this ordinance as if set out in full herein; and

4. The Chief of Police of the City of Oglesby is authorized to sign the attached Secondary Employment Indemnity and Conditions Agreements on behalf of the City of Oglesby.

5. This ordinance will be in full force and affect after its passage, approval, and publication in pamphlet form as provided by law.
