AN ORDINANCE AMENDING ORDINANCE NO. 818-111912 AND AN ORDINANCE  
AMENDING ORDINANCE NO. 1007-031918 MODIFYING RATES AND CHARGES  
FOR THE USE AND SERVICE OF THE ELECTRICAL SYSTEM OF  
THE CITY OF OGELSBY, LASALLE COUNTY, ILLINOIS

WHEREAS, the City of Oglesby adopted Ordinance No. 818-111912 entitled "An Ordinance Re-establishing Rates and Charges for the Use and Service of the Electrical System of the City of Oglesby, LaSalle County, Illinois, which Repeals all Prior Ordinances and Resolutions in Conflict Therewith" on November 19, 2012; and

WHEREAS, Ordinance No. 818-111912 established new rates for all users of the Oglesby Electrical System; and

WHEREAS, the City of Oglesby adopted Ordinance No. 1007-031918 entitled "An Ordinance Amending Ordinance No. 818-111912 entitled "An Ordinance Re-establishing Rates and Charges for the Use and Service of the Electrical System of the City of Oglesby, LaSalle County, Illinois, which Repeals all Prior Ordinances and Resolutions in Conflict Therewith"" on March 19, 2018;

WHEREAS, the City of Oglesby wants to make modifications to Ordinance No. 818-111912 as set forth in this ordinance; and

WHEREAS, the City of Oglesby does not intend to make any changes to the changes made to Ordinance No. 818-111912 by Ordinance No. 1007-031918; and

WHEREAS, Section 11-117-12 of the Illinois Municipal Code (65 ILCS 5/11-117-12 (West 2020)) authorizes the City of Oglesby to set rates for electrical service provided to residents of the City of Oglesby; and

WHEREAS, the mayor and commissioners of the City of Oglesby deem it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to amend Ordinance No. 818-111912 entitled "An Ordinance Re-establishing Rates and Charges for the Use and Service of the Electrical System of the City of Oglesby, LaSalle County, Illinois, which Repeals all Prior Ordinances and Resolutions in Conflict Therewith".

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble of this ordinance are incorporated by reference as if set out in full herein.

2. SECTION 1, B. GENERAL SERVICE WITHOUT DEMAND (GS-1), sub-paragraph 3. Rates, Sub-paragraph b. of Ordinance No. 818-111912 shall be amended to read as follows:

3. Rates:

a. The following rates shall be known as "General Service 1".

b. Customer service charge: \$17.95 per month.

c. Energy charge - All usage shall be charged: \$0.1105 per kWh effective April 1, 2021.

3. SECTION 3: Annual Operations Adjustment, of Ordinance No. 818-111912, Sub-paragraph A. NON-DEMAND METERED RATES and Sub-paragraph B. DEMAND METERED RATES shall be amended to read as follows:

A. NON-DEMAND METERED RATES:

is For rate R1, GS1, and M1 and all other non-demand metered rates; the energy charges Subsection 3.c are subject to an annual operations adjustment. Commencing with the first billing date for each customer after January 1, 2022 and continuing of the 1st day of January of each year thereafter, there shall be a five (5) percent increase to the customer service charge and a five (5) percent increase to the difference between the energy charge and the base energy charge of \$0.0846 per kWh as defined in the Power Cost Adjustment.

B. DEMAND METERED RATES:

For rate GS2 and all other demand metered rates; the energy charge in Subsection 3.c are subject to an annual operation adjustment. Commencing with the first billing date for each customer after January 1, 2022 and continuing of the 1st day of January of each year thereafter, there shall be a five (5) percent increase to the customer service charge; and an five (5) percent increase to the difference, if positive, between the first block energy charge per kWh and the base energy charge of \$0.0846 per kWh as defined in the Power Cost Adjustment.

4. All of the provisions of Ordinance No. 818-111912 entitled "An Ordinance Re-establishing Rates and Charges for the Use and Service of the Electrical System of the City of

Oglesby, LaSalle County, Illinois, which Repeals all Prior Ordinances and Resolutions in Conflict Therewith" and all of the provisions of Ordinance No. 1007-031918 entitled "An Ordinance Amending Ordinance No. 818-111912 Entitled "An Ordinance Re-establishing Rates and Charges for the Use and Service of the Electrical System of the City of Oglesby, LaSalle County, Illinois, which Repeals all Prior Ordinances and Resolutions in Conflict Therewith" not otherwise amended by this ordinance shall remain in full force and effect.

5. This ordinance shall be in full force and effect after its passage, approval and publication as provided by law.
