**RESOLUTION OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS,
AUTHORIZING THE MAYOR AND CLERK TO EXECUTE
A REVISED AGREEMENT BY AND BETWEEN
THE CITY OF OGLESBY AND LOCAL UNION NO. 51,
INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS**

WHEREAS, the CITY OF OGLESBY has previously executed a Labor Agreement with LOCAL UNION NO. 51 OF THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS covering a period commencing May 1, 2021, and ending April 30, 2025; and

WHEREAS, due to the Supreme Court's recent decision in AFSCME vs. Janus a change must be made to that Agreement to comply with the now applicable law; and

WHEREAS, the CITY OF OGLESBY and LOCAL UNION NO. 51 OF THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS desire to amend said existing Agreement so as to comply with said change in the law; and

WHEREAS, the corporate authorities of the CITY OF OGLESBY deem it to be in the best interest of the public health, safety and welfare of the residents of the CITY OF OGLESBY to authorize the Mayor and City Clerk of the City of Oglesby to execute said revised Agreement on behalf of the CITY OF OGLESBY,

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, AS FOLLOWS:

1. The recitals contained in the preamble to this Resolution are incorporated by reference as if set out in full herein.

2. The Mayor and City Clerk of the City of Oglesby are hereby authorized to execute said revised Agreement with LOCAL UNION NO. 51 OF THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS (a copy of which is attached hereto and made a part hereof).

3. This Resolution will be in full force and effect after its passage, approval and publication as provided by law.
