AN ORDINANCE PROVIDING FOR ADDITIONAL COMPENSATION FOR PATTY EICHELKRAUT

WHEREAS, after the resignation of former Oglesby City Clerk, Stacie Mertes and prior to the appointment of current Oglesby City Clerk, Amy Eitutis, Assistant City Clerk Patty Eichelkraut took on additional duties in order to assist the City of Oglesby in its transition from former City Clerk Mertes to current City Clerk Eitutis; and

WHEREAS, the corporate authorities of the City of Oglesby believe that Patty Eichelkraut should be compensated for these additional duties; and

WHEREAS, the corporate authorities of the City of Oglesby have decided that the City of Oglesby should award Patty Eichelkraut a one-time bonus for the additional work she performed; and

WHEREAS, Section 10-4-1 of the Illinois Municipal Code (65 ILCS 5/10-4-1) provides the City of Oglesby with broad authority to provide by ordinance in regard to the relation between all municipal officers and employees and the municipality and by implication would authorize the payment of the one-time bonus.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are incorporated by reference as if set out in full herein.

2. The City of Oglesby hereby authorizes a one-time bonus payment in the amount of Twelve Hundred (\$1,200.00) Dollars to Assistant City Clerk Patty Eichelkraut to reimburse Patty Eichelkraut for additional duties which she performed in the interim period between the resignation of former Oglesby City Clerk Stacie Mertes and current Oglesby City Clerk Amy Eitutis.

3. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
