ORDINANCE NO. 1209-010323

**AN ORDINANCE APPOINTING AN INTERIM CHIEF OF POLICE
FOR THE CITY OF OGLESBY, LASALLE COUNTY, IL**

WHEREAS, the Corporate Authorities of the City of Oglesby, LaSalle County, Illinois, have previously appointed DOUGLAS HAYSE as Police Chief for the City of Oglesby through the fiscal year ending April 30, 2023; and

WHEREAS, Chief Hayes has submitted his letter of resignation effective January 17, 2023; and

WHEREAS, the City of Oglesby has authority to establish and staff its police department pursuant to Section 11-1-1 of the Illinois Municipal Code (65 ILCS 5/11-1-1 (2018)); and

WHEREAS, the Corporate Authorities of the City of Oglesby desire to appoint an Interim Chief of Police for the City of Oglesby,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE: The recitals contained in the preamble to this Ordinance are restated and reincorporated by reference as if set out in full herein.

SECTION TWO: Mayor Dominic Rivara desires to appoint MICHAEL MARGIS as Interim Chief of Police for the City of Oglesby, LaSalle County, Illinois; and

SECTION THREE: The Corporate Authorities of the City of Oglesby do hereby approve and confirm of the Mayor's appointment of MICHAEL MARGIS as Interim Chief of Police for the City of Oglesby, LaSalle County, Illinois, effective January 18, 2023, until his successor is appointed.

SECTION FOUR: MICHAEL MARGIS shall be compensated for the performance of his duties as such Interim Chief of Police at the rate of Forty-four 11/100 Dollars (\$44.11) per hour. In exchange for said hourly compensation, said Interim Police Chief shall be required to be scheduled to work at least eighty-four (84) hours during each of the City's pay periods. In addition, MICHAEL MARGIS shall continue to enjoy all of the other benefits currently afforded him as Assistant Chief of Police for the City of Oglesby.

SECTION FIVE: If any section, subdivision, or sentence of this Ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portion of this Ordinance.

SECTION SIX: This Ordinance shall be in full force and effect after its passage, approval, and publication, as provided by law.
