

A REGULAR MEETING OF THE OGLESBY CITY COUNCIL WAS HELD ON MONDAY, DECEMBER 19TH, 2022 AT CITY HALL. THE MEETING WAS CALLED TO ORDER AT 7:00 P.M.

A MOTION IS MADE BY CURRAN, SECONDED BY ARGUBRIGHT to approve the minutes from the December 5th, 2022 regular meeting. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA.

A MOTION IS MADE BY ARGUBRIGHT, SECONDED BY EUTIS to approve bills in the amount of \$309,564.61 as presented for payment. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA.

A MOTION IS MADE BY EUTIS, SECONDED BY ARGUBRIGHT to approve the 2023 raffle license application for the Oglesby Ambulance Association. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA.

A MOTION IS MADE BY ARGUBRIGHT, SECONDED BY CURRAN to approve the purchase of a 2023 Ford Super Duty truck for the Maintenance Department in the amount of \$53,782.00. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA.

A MOTION IS MADE BY ARGUBRIGHT, SECONDED BY EUTIS to approve 1206-121922 an Ordinance levying taxes for all corporate purposes for the City of Oglesby, LaSalle County, Illinois, for the fiscal year beginning May 1, 2022 and ending April 30, 2023. AYES: ARGUBRIGHT, CULLINAN, EUTIS, RIVARA. NAYS: CURRAN Commissioner Curran verifies that the proposed ordinance is for option 1 that was discussed at the previous council meeting. Commissioner Curran points out that he believes it is wrong to raise taxes when the city is constantly showing a surplus.

A MOTION IS MADE BY ARGUBRIGHT, SECONDED BY CURRAN to approve 1207-121922 an Ordinance abating the taxes heretofore levied for the year 2022, payable in the year 2023, to pay debt service on general obligation refunding bonds (alternate revenue source) Series 2013 for the City of Oglesby, LaSalle County, Illinois. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA

A MOTION IS MADE BY ARGUBRIGHT, SECONDED BY CURRAN to Approve 1208-121922 an Ordinance Approving the Design and Review Board's Recommendation for the Application Filed by David Beavers Regarding the Property Located at 220 N Columbia in the City of Oglesby, LaSalle County, Illinois. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA Mayor Rivara

states the property is located across from the Rootbeer Stand and that the Design & Review Board met and made their recommendations for approval, Attorney Barry notes there are some stipulations to which Commissioner Argubright asks if Mr. Beavers has to follow through on them and is told yes.

A MOTION IS MADE BY EUTIS, SECONDED BY CURRAN to approve changes to 1204-112122 an Ordinance Establishing a Lateral Hiring Policy for Appointments to the Oglesby Police Department at the recommendation of the Fire and Police Board. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA. Commissioner Eutis explains that the Fire & Police Commission met and made changes to the bi-laws to the lateral list and notes the changes that were made on the ordinance were struck (the written test was removed and now will be done by oral exam and placed alphabetically on a list). Mayor Rivara asks for clarification on the two-year employment change.

A MOTION IS MADE BY CURRAN, SECONDED BY EUTIS to approve BHMGE Engineers, Inc. to go out for bids for a transformer for the Mallick Street substation. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA. Mayor Rivara reads the letter submitted from BHMGE Engineers, Inc. Commissioner Curran gives explanation behind the need of the additional transformer in that the City is currently almost at capacity. Commissioner Curran states the cost is estimated to be around \$600,000.00 and is at an approximate 28-month lead time. Commissioner Argubright states there really is no choice and asks about the possibility of a rebuilt transformer if it would be cheaper and quicker to receive? Commissioner Eutis states that is some of the reasons the city cannot respond to RFPs (request for proposals) because we cannot accommodate the infrastructure. Commissioner Argubright does want to see some options he states. Commissioner Curran states he will do that.

A MOTION IS MADE BY CURRAN, SECONDED BY ARGUBRIGHT to approve the 2023-2024 Façade Improvement Program. AYES: ARGUBRIGHT, CULLINAN, CURRAN, EUTIS, RIVARA. Mayor Rivara states the city will offer up \$100,000.00 towards the program and an ordinance will be drafted.

Cullinan: wishes everyone a Happy Christmas

Curran: well pump #3 is completed and is tested but is not online yet. Wishes everyone a Merry Christmas. Reminds residents about the parking during snowfall.

Mayor: Thanks everyone who helped make the Christmas event a success. Mayor Rivara also thanks everyone who donated to help make Shop with a Cop a success. The Christmas lighting contest will be judged on December 20, 2022 and the winners will be posted on the city's website. Solar construction should begin in the Spring. Commercial and electric rates were reduced by 15% and residential rates remain stable. In 2023, the City should be getting it's second feed from Ameren which will improve the electrical liability. In 2023 the city hopes to have charging stations in Oglesby as well. Mayor Rivara reads a letter that he drafted to IVCC in regards to electric rates and a commitment with the IMEA to build a one-megawatt solar facility. This proposal included four panels that IVCC could build into their curriculum in building/troubleshotting/dismantling solar. This proposal was rejected by the Board. The City also committed to bring its utilities to IVCC's proposed agricultural complex at a very fair price. Should IVCC annex into the city the college would have saved about \$ 500,000.00 in construction costs. Mayor Rivara also expresses his frustration regarding IVCC's refusal to grant the city the opportunity to present its proposal to the Board for discussion and consideration.

Mayor Rivara also discusses the city's legal battle with Ameren with unpaid city utility taxes. Mayor Rivara states Ameren forwards the utility tax for gas each month but estimates the revenue loss to be \$300,000.00 over 30 years. Mayor Rivara thanks Representative Lance Yednock and Senator Rezin for their help with this matter.

Mayor Rivara wishes everyone a Merry Christmas and a Happy New Year.
