ORDINANCE NO. 1215-040323

***AN ORDINANCE REGULATING STATIONARY GENERATORS
IN THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS***

WHEREAS, the Corporate Authorities of the City of Oglesby, LaSalle County, Illinois are vested with responsibility for protecting the public health, safety, and welfare of its citizens; and

WHEREAS, the Corporate Authorities of the City of Oglesby, LaSalle County, Illinois are concerned that the unregulated placement and installation of stationary electric generators create a potential danger to the public health, safety, and welfare of its citizens; and

WHEREAS, the Corporate Authorities of the City of Oglesby desire and find it in the best interest of the community to regulate the application for and installation of stationary electric generators within the corporate limits of the City of Oglesby,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois as follows:

SECTION 1. The recitals contained in the preamble to this Ordinance are restated as if set out in full herein.

SECTION 2. That there is enacted a section of the Oglesby Municipal Code titled "STATIONARY ELECTRIC GENERATORS" which shall state as follows:

- A. **Definitions.** For the purpose of this section a "stationary electric generator" shall be defined as a piece of permanent equipment that produces auxiliary, standby, or backup electrical power to a building, structure, or

portion thereof.

- B. Permit Required. No person shall install or replace a stationary electric generator within the City of Oglesby without first obtaining a permit for the installation of said generator from the City's Electrical Inspector.
- C. Applications for Permit. Application for such permit shall be made on forms provided by the City's Electric Department and the applicant shall comply with all requests and directives contained therein.
- D. Standard for Permits. In order to be approved, all proposed stationary electric generators must comply with the following standards:
 - (1) The unit shall not be located in a front yard or side yard facing a street.
 - (2) The unit shall be located at grade level.
 - (3) The unit must be located at least six (6) feet from a lot line.
 - (4) The unit shall not emit noise at a decibel level in excess of 70 db at full load as specified by the manufacturer of the equipment.
 - (5) The unit shall be connected to the customer's facilities with certain specified equipment to specifically include a disconnect switch that will not allow the generator to energize any City utility facilities.
- E. Specifications. Specifications regarding the generator and its proposed installation shall be submitted for review at the time of permit application.

SECTION 3. This Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
