ORDINANCE NO. 1220-050123

**AN ORDINANCE REVISING VARIOUS PROVISIONS OF SECTION 2.03
OF THE MUNICIPAL CODE OF THE CITY OF OGLESBY**

WHEREAS, the Mayor and Commissioners of the City of Oglesby desire to make amendments to Chapter 2.03 of the Oglesby City Code; and

WHEREAS, Section 4-5-2 of the Illinois Municipal Code (65 ILCS 5/4-5-2) authorizes the city council in a Commission form of Government by ordinance to determine the powers and duties to be performed by each department and assign them to the appropriate departments, prescribe the powers and duties of the officers and employees and make such other rules and regulations as may be necessary or proper for the efficient and economical conduct of the business of the municipality; and

WHEREAS, Oglesby City Council desires to make amendments to certain subparagraphs of Chapter 2.03 of the Oglesby City Code hereby reassigning certain powers and duties of various departments; and

WHEREAS, the Oglesby City Council deems the changes to be made by this Ordinance to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF
THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:**

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.
2. The following additional subparagraph is hereby added to Section 2.03.030 of the Municipal Code of the City of Oglesby:

- D. The Mayor can assist Commissioners with any personnel or human resource issues which they may have regarding employees under their supervision.

- 3. The existing paragraph "B. 9." of Section 2.03.040 of the Oglesby Municipal

Code is hereby deleted in its entirety and the following is hereby substituted in its place:

- 9. Have authority and supervision over the Auditor, City Treasurer, garbage collection (and all issues associated therewith), City Clerk and all respective offices or departments under any of such individuals and all employees therein, and all bookkeepers, stenographers and accountants, unless specifically excepted withing this Municipal Code.

- 4. The following additional subparagraphs are hereby added to Section 2.03.040 of the Municipal Code of the City of Oglesby:

- E. The commissioner shall be responsible for supervising the payment of all water, sewer and electrical rents and charges due and owing to the City (to specifically include delinquent accounts) and may prescribe rules and regulations relating thereto which are not inconsistent with any other law or City Ordinance.

- F. The Department of Accounts and Finance shall have authority and supervision over all persons or corporations rendering service to the City under any franchise, contract or grant made or granted by the City, including any contract for water or wastewater services entered into by the City. The commissioner shall report to the council or other proper officers the requirements or condition of the franchise, contract or grant under which such water or wastewater utility is operated, except as may be otherwise provided in this chapter.

- G. The commissioner shall have general oversight over the enforcement of the City's Land Development Code.

- 5. The existing paragraph "A." of Section 2.03.050 of the Oglesby Municipal

Code is hereby deleted in its entirety and the following is hereby substituted in its place:

- A. The commissioner of the department of public health and safety shall have charge of and supervision over the chief of police, the police department and all policemen, officers and employees therein, the police station and all jail property and apparatus used in the police department, any patrol systems, property or apparatus belonging thereto, and all officers, employees, property and apparatus used therein.

6. The existing paragraph "10." of Section 2.03.050 of the Oglesby Municipal Code is hereby deleted in its entirety:

7. The existing paragraph "A." of Section 2.03.060 of the Oglesby Municipal Code is hereby deleted in its entirety and the following is hereby substituted in its place:

A. The commissioner of the department of streets and public improvement shall have authority over and charge of the water department, the sewer department, the sewage treatment plant and the street department. The commissioner of streets and public improvements shall be responsible for the construction and repair of all City streets and public places, the entire erection, making and reconstruction of all street improvement, including paving, curbing and sidewalks. The commissioner of the department of streets and public improvement shall be in charge of all water and wastewater facilities, including sewers, bridges, viaducts and all public improvement and the repair of the same. The commissioner of streets and public improvements shall approve the estimates of the City engineer which may be made from time to time and the cost of such work as the same progresses and recommend to the Council the acceptance of work done in improvements made when completed according to contract or otherwise, and perform such other duties as may be required by ordinance or resolution, except as provided by law.

8. The existing paragraph "B. 3." of Section 2.03.060 of the Oglesby Municipal Code is hereby deleted in its entirety and the following is hereby substituted in its place:

3. Of all ordinances, resolutions, rules and regulations pertaining to the water department, the sewer department, the street department and the plumbing inspector and the commissioner may prescribe and enforce any other rules and regulations in order to work toward the efficient and economical management of the department, not in conflict with any law, ordinance or resolution

9. The existing paragraph "C." of Section 2.03.060 of the Oglesby Municipal Code is hereby deleted in its entirety.

10. The existing paragraph "D." of Section 2.03.060 of the Oglesby Municipal Code is hereby deleted in its entirety and the following is hereby substituted in its place:

D. The street superintendent and the water and sewer superintendent and their related departments, and all employees assigned to those departments shall be under the supervision and direction of the commissioner.

11. The existing paragraph "A." of Section 2.03.070 of the Oglesby Municipal Code is hereby deleted in its entirety and the following is hereby substituted in its place:


A. The commissioner of public property shall have charge over and supervision of the City's electric department and all City light and lighting, the City electrician, the City's building maintenance department and the City's meter reading and all other officers, assistants and attendant employees thereof. The commissioner of the department of public property shall have charge of and supervision over the City parks, all playgrounds, the City Hall building, the Dickinson House, the City's municipal swimming pool and all other municipal real estate not specifically controlled by another department, all plants, trees and shrubbery contained on any public property and all officers and employees used therein, except of the employees of the City Clerk's office, which shall fall under the supervision and authority of the commissioner of accounts and finances. The commissioner of the department of public property shall also have control over and supervision of all public landfills and the City's electric department and may prescribe and enforce any other rules and regulations in and effort to work toward the efficient and economical management of the City's electric department, not in conflict with any other law, ordinance or resolution.

12. All Ordinances or parts of Ordinances or provisions of the Municipal Code or rules or regulations of the City of Oglesby which are inconsistent with this Ordinance are hereby stricken and repealed.

13. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
