ORDINANCE NO. 1228-070523

AN ORDINANCE RESCINDING ORDINANCE 1168-062121, ENACTED JUNE 21, 2021, WHICH PROVIDED ADDITIONAL COMPENSATION FOR OGLESBY EMPLOEES ASSUMING THE ROLE OF EVENT PLANNERS

WHEREAS, the Mayor and Commissioners of the City of Oglesby previously enacted Ordinance #1168-062121, on June 21, 2021, which provided additional compensation to three (3) City employees to compensate them for taking on the additional role of event planners for the City of Oglesby; and

WHEREAS, two (2) of the three (3) designated individuals named in said Ordinance are either no longer employed by the City or have elected to resign their additional position as such an event planner; and

WHEREAS, at a recent meeting of the Oglesby City Council held on June 28, 2023, following discussion of the matter which was on the posted agenda, the Mayor and Commissioners of the City of Oglesby voted to rescind Ordinance # 1168-062121; and

WHEREAS, Ordinance 1168-062121 provided by its terms that it would continue in full force and effect “unless changed by subsequent Ordinance”; and

WHEREAS, the Mayor and Commissioners of the City of Oglesby deem it to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby to rescind Ordinance 1168-062121.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.

2. Ordinance #1168-062121, enacted by the Mayor and Commissioners of the City of Oglesby, LaSalle County, Illinois on June 6, 2021, is hereby fully rescinded, retroactive to the Council's vote on said matter on June 28, 2023.

4. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
