***RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE
AN INTERGOVERNMENTAL AGREEMENT WITH THE
OGLESBY FIRE PROTECTION DISTRICT FOR THE
PURCHASE OF A NEW TENDER TRUCK***

WHEREAS, the Oglesby Fire Protection District provides fire protection services to the residents of the City of Oglesby and other areas outside the City of Oglesby's corporate boundaries; and

WHEREAS, the Oglesby Fire Protection District is in need of a new tender truck and has identified one it would like to acquire; and

WHEREAS, the City of Oglesby is willing to purchase the identified tender truck for the Oglesby Fire Protection District's use, subject to the District's written agreement to repay the City of Oglesby for a portion of the purchase price and interest paid to accomplish the purchase of said tender truck; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Resolution are incorporated by reference as if set out in full herein.

2. The City Council of the CITY OF OGLESBY does hereby grant the Mayor of the CITY OF OGLESBY authority to execute the proposed Intergovernmental Agreement with the Oglesby Fire Protection District to accomplish said purchase, a copy of which is attached hereto, marked "Exhibit A" and made a

part hereof.

3. This Resolution will be in full force and effect after its passage, approval and publication as provided by law.

INTERGOVERNMENTAL AGREEMENT
BETWEEN THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS
AND THE OGLESBY FIRE PROTECTION DISTRICT
FOR THE PURCHASE AND PAYMENT OF A FIRE TENDER TRUCK

THIS INTERGOVERNMENTAL AGREEMENT (hereinafter "Agreement") is made this 26 day of June, 2023, by and between the CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, an Illinois Municipal Corporation (hereinafter "OGLESBY") and the OGLESBY FIRE PROTECTION DISTRICT (hereinafter "DISTRICT"), and is intended to formalize an agreement between the parties for the purchase and repayment of a tender truck for the DISTRICT.

WHEREAS, the DISTRICT provides fire protection services to the residents of OGLESBY and other areas outside OGLESBY'S corporate boundaries; and

WHEREAS, the DISTRICT is in need of a new tender truck and has identified one it would like to acquire; and

WHEREAS, OGLESBY is willing to purchase the identified tender truck for the DISTRICT'S use, subject to the DISTRICT'S repayment to OGLESBY of a portion of the purchase price and interest paid to accomplish the purchase of said tender truck as specified herein; and

WHEREAS, the parties to this Agreement are authorized to enter into this Agreement so as to allow for the purchase and partial repayment of said tender truck,

This Agreement shall be effective upon its signature by both parties. No modification to this Agreement shall be valid or binding unless the modification is in writing, duly dated and signed by both parties.
