### AN ORDINANCE GRANTING A REQUEST FOR VARIANCE FILED BY KEVIN DUTKIEWICZ SO AS TO REDUCE THE FRONT YARD SETBACK LINE ON THE SOUTH SIDE OF HIS PROPERTY FROM TWENTY-FIVE (25) FEET TO FIFTEEN (15) FEET

WHEREAS, the City of Oglesby received a request for variance filed by KEVIN DUTKIEWICZ for property located at 218 W Third Street in the City of Oglesby, LaSalle County Illinois; and

WHEREAS, the Oglesby City Council referred his request to the Oglesby Zoning Board of Appeals for consideration; and

WHEREAS, the Oglesby Zoning Board of Appeals conducted a public hearing on September 11, 2024, after due notice as provided in the Illinois Municipal Code and the Oglesby Land Development; and

WHEREAS, at the conclusion of said hearing the Oglesby Zoning Board of Appeals unanimously recommended to the Oglesby City Council that a variance be granted by the City, reducing the front yard set-back line from Twenty-five (25) feet to Fifteen (15) feet, as set forth herein; and

WHEREAS, Section 11-13-5 of the Illinois Municipal Code (65 ILCS 5/11-13-5) authorizes municipalities to grant variances from the strict application of municipal zoning ordinances; and

WHEREAS, the Oglesby City Council deems it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to adopt this Ordinance to formalize the grant of variance recommended by the Oglesby Zoning Board of Appeals on September 11, 2024,

# NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.
- 2. The front setback line distance for the property located at 218 W. Third Street, in the City of Oglesby, LaSalle County, Illinois, is hereby reduced from Twenty-five (25) feet to Fifteen (15) feet, which property is legally described as follows.

Lots One (1) and Two (2) in Block One (1) in Snedden's Third Subdivision, being a part of Lot Three (3) in the Subdivision of the West Fifty-two (52) acres of the East Sixty (60) acres of the North Half of the Northwest Quarter of Section Thirty-six (36), Township Thirty-three (33) North, Range One (1), East of the Third Principal Meridian, in the City of Oglesby, excepting underlying coal and mining rights, situated in the County of LaSalle, in the State of Illinois.

3. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
