AN ORDINANCE GRANTING REQUESTS FOR VARIANCE FILED BY KNBZ LLC/WESBECKER PROPERTIES SO AS TO ALLOW FOR THE CONSTRUCTION OF A COFFEE TRAILER BUSINESS ON THE SOUTHEAST CORNER OF WALNUT STREET AND COLUMBIA AVENUE IN THE CITY OF OGLESBY

WHEREAS, the City of Oglesby received a request for variances from KNBZ LLC/WESBECKER PROPERTIES for property located at 459 West Walnut Street in the City of Oglesby, LaSalle County Illinois; and

WHEREAS, the Oglesby City Council referred this matter to the Oglesby Zoning Board of Appeals for consideration; and

WHEREAS, prior to the hearing before the Oglesby Zoning Board of Appeals, it was determined that one of the variances requested by the property owner for the waiver of a fence requirement was not required due to the neighboring property being a commercial property and not a residential property, thus eliminating the fencing requirement otherwise required by section 14.06.120 of the City's Land Development Code; and

WHEREAS, the Oglesby Zoning Board of Appeals conducted a public hearing on February 12, 2024, after due notice as provided in the Illinois Municipal Code and the Oglesby Land Development; and

WHEREAS, at the conclusion of said hearing the Oglesby Zoning Board of Appeals recommended to the Oglesby City Council that the remaining 3 requested variances be granted by the City, as set forth herein; and

WHEREAS, at its regularly scheduled meeting held on February 20, 2024, the City

Council of the City of Oglesby, LaSalle County, Illinois, approved the remaining three variance requests, as set forth herein, allowing for the placement and development of the property for the intended coffee trailer business; and

WHEREAS, Section 11-13-5 of the Illinois Municipal Code (65 ILCS 5/11-13-5) authorizes municipalities to grant variances from the strict application of municipal zoning ordinances; and

WHEREAS, the Oglesby City Council deems it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to adopt this Ordinance to formalize the grant of variance requests recommended by the Oglesby Zoning Board of Appeals and previously approved by the Oglesby City Council on February 20, 2024,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.

2. There is hereby granted the following three variances for the property located at 459 West Walnut Street, in the City of Oglesby, LaSalle County, Illinois, which property is legally described as follows.

C. A variance from section 14.09.140 (L) of the Oglesby Land Development Code so as to eliminate the requirement for the construction of storm sewer management facilities on the property described above.

publication in pamphlet form as provided by law.
