ORDINANCE NO. 1266-081924

AN ORDINANCE AMENDING AND ESTABLISHING THE SALARY AND BENEFITS FOR THE OGLESBY AMBULANCE SERVICE EXECUTIVE DIRECTOR

WHEREAS, the City Council of the City of Oglesby reviews the responsibilities and compensation packages of its employees from time to time; and

WHEREAS, the City Council of the City of Oglesby recently reviewed the compensation package of its appointed Ambulance Service Executive Director and desires to adjust her compensation package as stated herein; and

WHEREAS, Section 4-6-2 of the Illinois Municipal Code (65 ILCS 5/4-6-2) authorizes the City of Oglesby to set compensation for all officers and employees of the City of Oglesby; and

WHEREAS, the Mayor and City Council of the City of Oglesby deem it to be in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to adopt an ordinance adjusting the salary and benefits to be paid to its Ambulance Service Executive Director,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The recitals contained in the preamble to this Ordinance are restated and incorporated by reference as if set out in full herein.
- 2. For the period commencing May 1, 2024, and continuing until hereafter amended, the Ambulance Service Executive Director of the City of Oglesby, LaSalle County, Illinois shall be paid an annual salary of Sixty-six Thousand, Nine Hundred

Thirteen and no/100 Dollars (\$66,913.00). All other benefits and the job requirements for said position shall remain the same. In addition, the City agrees to pay said Ambulance Service Executive Director for Five Hundred Thirty (530) hours of sick time over a three (3) month period, at her new salary rate, commencing with the City's next payroll cycle.

- 3. The salary for the City's Ambulance Service Executive Director specified in paragraph "2." of this Ordinance shall be paid retroactive to May 1, 2024.
- 4. This Ordinance shall apply so long as CATHIE EDENS is the acting Ambulance Service Executive Director for the City of Oglesby. In the event of her retirement, resignation or discharge, the salary and benefits provided in this Ordinance shall terminate and any newly appointed Ambulance Service Executive Director shall be paid wages and benefits to be determined by an Ordinance adopted by the City Council of the City of Oglesby at the time of the appointment of a new Ambulance Service Executive Director
- 7. This Ordinance shall be in full force and effect from and after its passage, approval and due publication in pamphlet form as provided by law.
- 8. The City Clerk is hereby instructed to publish this Ordinance in pamphlet form as required by law.
