ORDINANCE NO. 1237-091823

**AN ORDINANCE REVISING PARAGRAPHS “A.” & “B.” OF SECTION 8.52.020
OF THE MUNICIPAL CODE OF THE CITY OF OGLESBY
RELATING TO THE BURNING OF COMBUSTIBLE REFUSE**

WHEREAS, the corporate authorities of the City of Oglesby have previously enacted Ordinances codified in Chapter 8.52 of the Municipal Code of the City of Oglesby relating to the burning of combustible refuse; and

WHEREAS, the Mayor and Commissioners of the City of Oglesby desire to amend paragraphs “A.” & “B.” of Section 8.52.020 of said Chapter relating to the permitted days and times for the burning of combustible refuse and to clarify and strictly prohibit the use of “burn barrels”; and

WHEREAS, the Oglesby City Council deems the changes to be made by this Ordinance to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF
THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:**

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.

2. The existing paragraphs “A.” & “B.” of Section 8.52.020 of the Municipal Code of the City of Oglesby are hereby deleted in their entirety and the following new paragraphs “A.” & “B.” are hereby substituted in their place:

A. No person shall cause or allow to be caused the burning of any refuse or waste, except as provided in Section 8.52.030 through 8.52.050. Permitted burnings pursuant to Section 8.52.030 A. shall be allowed from March 15th through December 31st, but only between the hours of 8 A.M. and 6 P.M. and only on Thursdays, Fridays and Saturdays. Recreational fires, as allowed by Section 8.52.030 C., are permitted at any

time on any day except Mondays.

B. No person shall cause or allow to be caused the burning of any permitted refuse or waste in any chamber or apparatus, unless such chamber or apparatus is specifically designed for the purpose of disposing of the class of refuse being burned therein. For purposes of clarification, the use of any "burn barrel" is strictly prohibited. For purposes of this Section, a burn barrel is hereby defined as any barrel or similar container which is being used for or which has been modified so as to allow for the burning of refuse.

3. All Ordinances or parts of Ordinances or provisions of the Municipal Code or rules or regulations of the City of Oglesby which are inconsistent with this Ordinance are hereby stricken and repealed.

4. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
