ORDINANCE NO. 1235-090523

AN ORDINANCE REVISING THE MAXIMUM HOURLY WAGE TO BE PAID TO PART TIME EMPLOYEES OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS

WHEREAS, from time to time the corporate authorities of the City of Oglesby have previously enacted Ordinances establishing the maximum hourly wage to be paid to parttime employees of the City of Oglesby; and

WHEREAS, due to changes in the labor market and in an effort to attract talented employees, the corporate authorities desire to increase the maximum hourly rate to be paid to part time employees of the City of Oglesby to Twenty and no/100 Dollars (\$20.00) per hour; and

WHEREAS, the Mayor and Commissioners of the City of Oglesby deem the change to be made by this Ordinance to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.

2. The maximum hourly rate to be paid to part time employees of the City of Oglesby, LaSalle County, Illinois is hereby increased to Twenty and no/100 Dollars (\$20.00) per hour.

3. All Ordinances or parts of Ordinances or provisions of the Municipal Code or

rules or regulations of the City of Oglesby which are inconsistent with this Ordinance are hereby stricken and repealed.

4. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
