**ORDINANCE NO 1255-060324**

**AN ORDINANCE AMENDING SECTION 5.08.200 OF THE MUNICIPAL CODE OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, REDUCING THE NUMBER OF CLASS D LIQUOR LICENSES FROM “THREE” TO “TWO”**

**WHEREAS**, the Municipal Authorities of the City of Oglesby County, Illinois, have previously enacted ordinances codified in Section 5.08.200 of the Municipal Code of the City of Oglesby, LaSalle County, Illinois regulating the number of Liquor Licenses by Class; and

**WHEREAS**, said subparagraph “H. 3.” of said Section currently restricts the issuance of Class D Liquor licenses to a maximum of three (3); and

**WHEREAS**, the Municipal Authorities of the City of Oglesby, LaSalle County, Illinois, desire to decrease the maximum number of Class D liquor licenses from three to two; and

**WHEREAS**, it is in the best interests of the residents of the City of Oglesby, LaSalle County, Illinois, to decrease the maximum number of Class D Liquor Licenses from three to two,

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:**

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.

2. That existing subparagraph “H. 3.” of Section 5.08.200 of the Municipal Code of the City of Oglesby, LaSalle County, Illinois is hereby repealed.

3. That the following new subparagraph “H. 3.” for said Section Is hereby substituted in its place:

“3. The number of Class D licenses within the city shall be limited to two.”

4. This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
