AN ORDINANCE GRANTING A REQUEST FOR VARIANCE FILED BY RICHARD GREENING AND SHELLY GREENING SO AS TO ALLOW FOR AN ACCESSORY STRUCTURE TO EXIST ON LOT 62 IN DALE'S SUBDIVISION OF LOT "B" IN DALE'S SUBDIVISION IN THE CITY OF OGLESBY WITHOUT THE EXISTENCE OF A PRINCIPAL STRUCTURE

WHEREAS, the City of Oglesby received a request for variance filed by RICHARD GREENING and SHELLY GREENING for property located at 128 W First Street in the City of Oglesby, LaSalle County Illinois; and

WHEREAS, the Oglesby City Council referred their request to the Oglesby Zoning Board of Appeals for consideration; and

WHEREAS, the Oglesby Zoning Board of Appeals conducted a public hearing on January 2, 2025, after due notice as provided in the Illinois Municipal Code and the Oglesby Land Development; and

WHEREAS, at the conclusion of said hearing the Oglesby Zoning Board of Appeals recommended to the Oglesby City Council that a variance be granted by the City so as to allow for an accessory structure to exist on Lot 62 in Dale's Subdivision of Lot "B" in Dale's Subdivision in the City of Oglesby without the existence of a principal structure, so long as separate water service lines are established for each structure; and

WHEREAS, Section 11-13-5 of the Illinois Municipal Code (65 ILCS 5/11-13-5) authorizes municipalities to grant variances from the strict application of municipal zoning ordinances; and

WHEREAS, the Oglesby City Council deems it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to adopt this Ordinance to formalize the grant of variance recommended by the Oglesby Zoning Board of Appeals on January 2, 2025,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.
- 2. That the accessory structure currently existing on Lot 62 in Dale's Subdivision shall be allowed to continue to exist without the existence of a principal structure on said lot once it is separated from Lot 61 in said subdivision, so long as separate water service lines are established for each structure. Said property is legally described as follows.

Lots 61 and 62 in Dale's Subdivision of part of Lot "B in Dale's Subdivision of part of the West 22 acres of the East 30 acres of the North Half of the Northwest Quarter of Section 36, in Township 33 North, Range 1 East of the Third Principal Meridian, in the City of Portland, now Oglesby, except coal and minerals and the right to mine and remove the same; situated in LaSalle County, Illinois.

3. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
