ORDINANCE NO.1282-021825

AN ORDINANCE ESTABLISHING THE TERMS OF EMPLOYMENT AND COMPENSATION FOR THE OGLESBY ASSISTANT CHIEF OF POLICE

WHEREAS, the corporate authorities of the City of Oglesby did recently appoint EVAN DUTTLINGER as Assistant Chief of Police for the City of Oglesby, LaSalle County, Illinois, on January 6. 2025; and

WHEREAS, the corporate authorities of the City of Oglesby recently reached an agreement on the compensation to be paid to the said EVAN DUTTLINGER, commencing January 6, 2025, through the end of the City's current fiscal year on April 30, 2025; and

WHEREAS, the City of Oglesby desires to modify any previous Ordinance establishing the rate of compensation and benefits provided to the Oglesby Assistant Chief of Police; and

WHEREAS, Section 11-1-1 of the Illinois Municipal Code (65 ILCS 5/1 1-1-1) authorizes the City of Oglesby to pass and enforce all necessary police ordinances which would include provisions authorizing the provisions of compensation to its Assistant Chief of Police,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are restated and reincorporated by reference as if set out in full herein.

2. The hourly rate of compensation for EVAN DUTTLINGER as the Assistant Chief of Police for the City of Oglesby shall be \$42.40 per hour, commencing and paid retroactively to January 6, 2025, and ending April 30, 2025.

In exchange for said hourly compensation, the Assistant Police Chief for the City of Oglesby will be required to be scheduled to work at last eighty-four (84) hours during each of the City's pay periods, totaling Two Thousand, One Hundred Eighty hours in each calendar year. The Assistant Chief for the City of Oglesby shall be paid overtime compensation at the rate of one and one-half (1.5) times any hourly rate specified herein as required by law for all hours in excess of statutory limitations. As a general rule, overtime shall be offered to FOP contract members first. However, when there are multiple FOP bargaining unit members off, it is understood that the Assistant Police Chief may work overtime to reduce force backs. As is the current practice, the Assistant Chief of Police shall adjust his schedule to alleviate officer overtime. The Assistant Chief of Police shall be entitled to shift differential, but shall not receive longevity pay.

- 3. With respect to health insurance benefits, the City of Oglesby will pay health insurance premiums for the Assistant Chief of Police of the City of Oglesby in the same amount as the City of Oglesby is obligated to pay for health insurance premiums for members of the Oglesby Police Department covered under the union contract entered into between the City of Oglesby and the Oglesby Fraternal Order of Police.
- 4. With respect to other benefits, including but not limited to vacation days, sick days, holidays, leave of absence benefits and clothing allowance, the Assistant Chief of Police for the City of Oglesby shall receive the same benefits as those such benefits negotiated between the City of Oglesby and the Oglesby Illinois Fraternal

Order of Police Labor Council as established in any such Collective Bargaining

Agreement then in effect, including any buy back options

- 5. This Ordinance shall apply so long as Assistant Oglesby Police Chief EVAN DUTTLINGER holds the position of Assistant Chief of Police in the City of Oglesby. In the event of his retirement, resignation or discharge, the salary and benefits provided in this Ordinance shall terminate and any newly appointed Assistant Chief of Police will be paid wages and benefits to be determined by an Ordinance adopted by the City Council of the City of Oglesby at the time of the appointment of a new Assistant Chief of Police.
- 6. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
